RESOLUTION OF CITY AND BOROUGH OF JUNEAU, ALASKA

(Special Police Protection Committee Substitute 8-27-82)

A RESOLUTION TO PLACE ADVISORY PROPOSITIONS
RELATING TO POLICE PROTECTION SERVICES ON THE
BALLOT FOR THE NEXT REGULAR ELECTION.

WHEREAS, police protection is provided by the municipality only in the Douglas and Juneau Service Areas, and

WHEREAS, a majority of the city and borough population resides outside these two areas, and

WHEREAS, the municipal criminal and traffic codes are not enforced by the state troopers, and

WHEREAS, the Douglas Service Area receives a lower level of police protection services than the Juneau Service Area, and

WHEREAS, all citizens of the City and Borough of Juneau should receive adequate police protection, and

WHEREAS, the citizens of the various areas within the city and borough should be given an opportunity to express their desires relating to the level of police protection they desire to receive;

NOW, THEREFORE, BE IT RESOLVED BY THE ASSEMBLY OF THE CITY AND BOROUGH OF JUNEAU, ALASKA:

1. That the following advisory propositions to be voted on by voters in the Juneau Service Area shall be placed on the ballot at the regular municipal election to be held on October 5, 1982:

(Advisory Proposition)
