CBJ operations continue with staff reassigned to EOC functions where appropriate. Minor staff outages due to childcare and medically advised quarantine. Staffing issues are not impairing operations.

BRH Operations continue as normal. They have limited staff out due to illness or quarantine. Staffing issues are not impairing operations.

Supply chain is operational with no significant reported shortages.

EOC Highlights

EOC is part way through Operational Period 6.

Dashboard is [live](#): The communications team will push out information this evening or tomorrow.

Issues on the critical path include set up and staffing for quarantine and isolation and childcare for essential workers. Good progress was made today developing strategies with BRH, JEMA and other mental health providers to set up appropriate operational strategies for quarantine and isolation populations.

Operational Highlights

CBJ operations continue with staff reassigned to EOC functions where appropriate. Minor staff outages due to childcare and medically advised quarantine. Staffing issues are not impairing operations.

BRH Operations continue as normal. They have limited staff out due to illness or quarantine. Staffing issues are not impairing operations.

Airport Screening: 8 passengers out of 34 arriving went through the voluntary screening process at the airport.

Mobile Screening: 15 calls came into the call center. 5 tests at drive through. To date, sampled 119 for testing.

Vessel Screening: Reached out to local marine freight companies for approved plans. Next ferry arrives on Friday.

Warming Shelter: had 47 individuals overnight.

FTE: Working with shelter providers to stand up a feeding station at the covered playground at Zach Gordon.

Logistics: State EOC is working on filling our requests. Looks like it is moving in the right direction.

Centennial Hall: The building should be cleared out and ready for set up by tomorrow. JAHC is able to provide custodial services. Continued work on logistical planning and staffing requirements.

Volunteer Taskforce: There are 218 volunteers in the queue. 123 have been referred to the following activities: Assist with sewing, cutting, and taping none PPE and PPE mask, drive for Meals on Wheels, screen incoming travelers, help Staff the Warming Shelter, and deliver food boxes to families and individuals in need through the Salvation Army.

They have received 28 requests for assistance. There are an increased number of calls about rent/mortgage assistance and/or utility payment assistance.
