CLARIFICATIONS:

Question: Does the wall texture extend above the ceiling?

Response: It is unknown whether the wall texture extends above the ceiling. Since the ceilings are

all hard gypsum ceiling, there was no access to the space above during design. It is unlikely that the wall texturing extends above the ceiling as texturing would typically be

applied after the wall and ceiling coverings were both installed.

Question: Is there a sprinkler system in the building that needs to be monitored by the fire alarm

system?

Response: No, there is not a sprinkler system that needs to be monitored by the fire alarm system.

Question: Are there any air handlers or RTU's that need duct detectors or have integral detectors

that need to be monitored?

Response: No, there are not any air handlers or RTUs that need duct detectors or integral detectors

that need to be monitored by the fire alarm system.

PROJECT MANUAL:

Item No. 1 SECTION 00800 SUPPLEMENTARY GENERAL CONDITIONS, SGC 6.5 CONCERNING SUBCONTRACTORS, SUPPLIERS, AND OTHERS, Paragraph B. Replace Paragraph B with the following:

"B. The CONTRACTOR shall perform not less than 20% of the WORK with its own forces (i.e., without subcontracting). The 20% requirement shall be understood to mean that the CONTRACTOR shall perform, with its own organization, WORK amounting to at least 20% of the original contract amount. The 20% requirement will be calculated based upon the total of the subcontract amounts submitted for Contract Award, and any other information requested by the OWNER from the apparent low Bidder."

Item No. 2 SECTION 284621.11 ADDRESSABLE FIRE-ALARM SYSTEMS, 3.3 PATHWAYS Replace Paragraph A with the following:

"A. Provide pathways in non-concealed spaces."

Add the following Note 3:

"3. All circuits in concealed spaces including attics, above ceiling and inside walls may be open cables."
