**Situational Update – Incident Level 2 - Operational Period 12 (5/07/2020 – 5/14/2020).**

Disease Transmission/Contact Tracing:

DHSS announced two new COVID-19 cases in Juneau today. Both cases are considered secondary transmission from the pocket of employees who tested positive at LCCC. DPH has identified 10 individuals that they are tracking as a result of the new cases being identified.

Testing:

Testing capacity and supplies remain good for current levels of testing. The EOC continues to explore options for increasing the ability for local testing. Testing of people who are currently experiencing homelessness is tentatively scheduled for early next week.

Hospital Response:

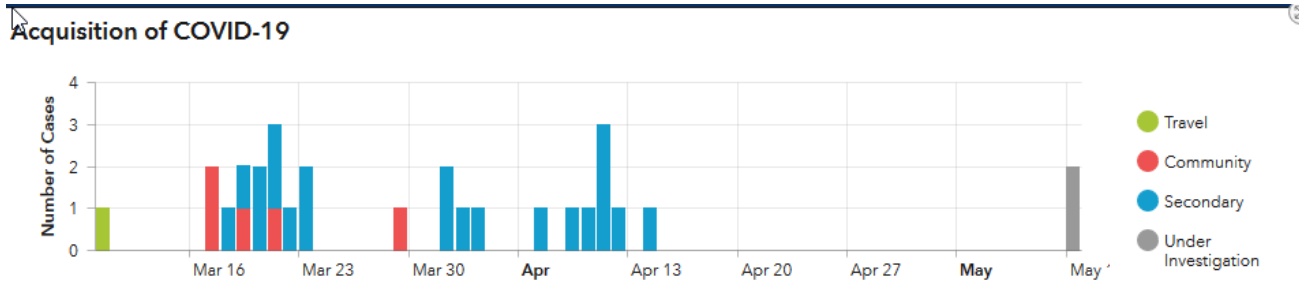
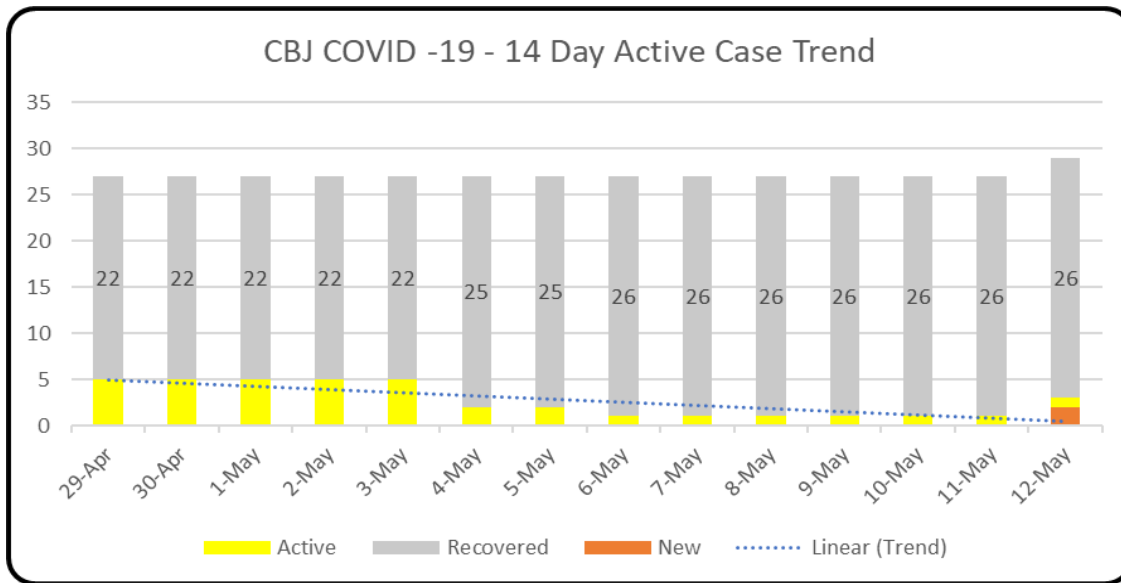
BRH reports adequate supply of PPE and no concerns related to workforce availability.

Issues of Note:

AMHS vessels (Kennecott & Columbia) are currently scheduled to sail out of Bellingham beginning June 27<sup>th</sup>. EOC will work with AMHS to assure proper protocols are in place if still needed at that time.
