RE: City & Borough of Juneau COVID-19 Response – Emergency Operations Center Update

Situational Update – Incident Level 2 - Operational Period 17 (7/9/2020 – 7/23/2020).

<u>Disease Transmission/Contact Tracing:</u>

There are 39 new statewide resident cases being reported today and 10 new statewide non-resident cases. Within these numbers, 3 residents and 3 non-residents are attributed to Juneau; however, we are the reporting 4 residents and 4 non-residents from yesterday's EOC report on our dashboard today. We expect the difference is due to reporting lag and anticipate corrections over the weekend. All individuals identified as close contacts have been contacted and are isolating or quarantining, as appropriate.

Contact tracing continues to be strained statewide.

Testing:

Staff and collection supplies are unconstrained. The Anchorage lab continues to operate at half capacity and we expect turnaround times to increase in the coming days. Currently, we are seeing – on average – 4 day turnarounds.

Hospital Response:

BRH reports adequate supply of PPE and no concerns related to workforce availability. There is one new hospitalized COVID-19 case today.


<u>Issues of Note:</u>

The EOC focus for today was on public communication, testing, and the COVID-19 hotline transition.



Acquisition of COVID-19


