RE: City & Borough of Juneau COVID-19 Response – Emergency Operations Center Update

Situational Update – Incident Level 2 - Operational Period 17 (7/9/2020 – 7/23/2020).

<u>Disease Transmission/Contact Tracing:</u>

There are 82 new statewide resident cases being reported today and 37 new statewide non-resident cases. Within these numbers, 4 residents and 1 non-resident are attributed to Juneau.

In addition, there are 26 new cases associated with the cluster of 9 reported earlier this week at Alaska Glacier Seafoods. All of these individuals are isolating. We are working closely with AGS and the Division of Public Health to provide assistance and support as needed. These new cases are not yet included in the data below as we work to identify which specific cases have been reported versus those yet to be reported by the state.

Contact tracing continues to be strained statewide. Our local division of public health staff are working actively to investigate these new cases.

Testing:

Staff and collection supplies are unconstrained. The Anchorage lab continues to operate at half capacity and we expect turnaround times to increase in the coming days. Currently, we are seeing – on average – 4 day turnarounds.

Hospital Response:


BRH reports adequate supply of PPE and no concerns related to workforce availability.

Numbers changed from yesterday are highlighted. The DPH PUI # is not updated over the weekend.





Acquisition of COVID-19
