 RE: City & Borough of Juneau COVID-19 Response – Emergency Operations Center Update

Situational Update – Incident Level 2 - Operational Period 18 (7/23/2020 – 8/6/2020).

Disease Transmission/Contact Tracing:

The state is reporting 65 new statewide resident cases and 5 new statewide non-resident cases. Within these numbers, no new resident and 1 non-resident are attributed to Juneau. The EOC numbers in the table below don't match the state reported numbers today – the EOC has access to more timely data and our numbers continue to reflect that information.

Contact tracing continues to be strained statewide. DPH reported that they are following 26 individuals locally, not including the AGS positive employees.

Testing:

Staff and collection supplies are unconstrained. A total of 95 people employed by AGS were tested yesterday. CBJ Testing operations is reporting the majority of tests yesterday were from July 19th, with the spread being as little as 2 days and as much as 5 days. We do not have access to turnaround times from private providers.

Hospital Response:

BRH reports adequate supply of PPE and no concerns related to workforce availability. They have 2 COVID positive patients currently in the hospital.


Issues of Note:

We continue to get general questions about masking and are working through related issues as they arise. A new operational period began today.





Acquisition of COVID-19
