 RE: City & Borough of Juneau COVID-19 Response – Emergency Operations Center Update

Situational Update – Incident Level 2 - Operational Period 18 (7/23/2020 – 8/6/2020).

Disease Transmission/Contact Tracing:

The state is reporting 88 new statewide resident cases and 31 new statewide non-resident cases. Within these numbers, 1 resident and no non-resident cases are attributed to Juneau.

NOTE: Test results are beginning to come back from the last round of AGS testing, and DPH is reporting an additional 21 positives today – 3 resident and 18 nonresidents. Those numbers are reflected in the table below, the state dashboard will lag in reporting those numbers. So far, 57 of the 96 test results have come back, the remainder are expected sometime between later tonight and Monday morning. If the positives follow the same pattern, it is possible that there will be another 10 – 15 positive test results from the remaining tests. The EOC is working with AGS to relocate some of their positive employees to allow for appropriate isolation from other housed employees.

Contact tracing continues to be strained statewide.

Testing:

Staff and collection supplies are unconstrained. CBJ testing operations is reporting the significant majority of tests yesterday were from July 21st and 22nd. 3 – 4 days after the tests were taken. We do not have access to turnaround times from private providers.

Hospital Response:

BRH reports adequate supply of PPE and no concerns related to workforce availability.


Issues of Note:

We continue to work with AGS in helping them manage issues associated with their workplace cluster.


Numbers changed from yesterday are highlighted. DPH updated positives associated with the AGS cluster, but did not update other numbers.



Acquisition of COVID-19
