 RE: City & Borough of Juneau COVID-19 Response – Emergency Operations Center Update

Situational Update – Incident Level 2 - Operational Period 18 (7/23/2020 – 8/6/2020).

Disease Transmission/Contact Tracing:

The state is reporting 186 new statewide resident cases and 48 new statewide non-resident cases. Within these numbers, 2 resident and no non-resident cases are attributed to Juneau. The EOC numbers in the table below are still above those in the state dashboard due to conversations with DPH.

Contact tracing continues to be strained statewide. Individuals who test positive are being asked to contact their close contacts and let them know they've tested positive. This assists DPH when they call the individual, and helps assure that any risk of delay in communicating the need to quarantine is mitigated.

Testing:

Staff and collection supplies are unconstrained. CBJ testing operations is reporting the significant majority of tests yesterday (97 out of 100 received) were from July 22nd to July 23rd 3 – 4 days after the tests were taken. We do not have access to turnaround times from private providers.

Hospital Response:

BRH reports adequate supply of PPE and no concerns related to workforce availability.


Issues of Note:

The EOC continues to monitor the AGS situation as well as test turnaround times.


Numbers changed from yesterday are highlighted. There is no additional information from DPH today.



Acquisition of COVID-19
