RE: City & Borough of Juneau COVID-19 Response – Emergency Operations Center Update

Situational Update - Incident Level 2 - Operational Period 18 (7/23/2020 - 8/6/2020).

<u>Disease Transmission/Contact Tracing:</u>

The state is reporting 98 new statewide resident cases and 6 new statewide non-resident cases. Within these numbers, 3 resident and no non-resident cases are attributed to Juneau. The EOC numbers in the table below are still above those in the state dashboard due to conversations with DPH.

We have a small charter boat with 8 people aboard moored in one of our harbors that has 2 positive nonresidents aboard. The passengers were picked up in another SE community and learned of their COVID status after they set sail. The EOC is monitoring their situation and providing support as needed while they wait out their isolation period.

Contact tracing continues to be strained statewide. They are working on hiring and onboard new staff.

Testing:

Staff and collection supplies are unconstrained. The state did not update their testing dashboards today.

Hospital Response:

BRH reports adequate supply of PPE and no concerns related to workforce availability.


<u>Issues of Note:</u>



Numbers changed from yesterday are highlighted. Testing numbers were not updated by the state today so the numbers below reflect Sunday's report.


