M. Jensen: We have had two weddings and a lot of inquiries this year but the max of 50 people is the main hang up. But 50 is a good number and we're going to stick with it. Our spruces are compromised for the season with aphid damage but they're still alive. 14 students attended the REACH camp.

Parking—city engineering and Alaska DOT came out but it is the Feds that are holding us up. They gave us some good recommendations for how to handle the situation. This is a federal road and they write the regulations but there are

exceptions, i.e. the forest service trailheads. City engineering is drawing up a couple proposals that they will pass along to the Feds sometime in September or October. We will have a public meeting sometime this winter and hopefully start breaking ground next spring.

The Chilkat Shelter has about 3 hours left till it will be complete. Our plum tree was removed because of porcupine damage. I'm part of the GLORIA group and will be laying out plots to monitor climate change in southeast and we're looking at Blackerby, below camp 17. Our Grand Old Apple Tree was DNA tested and it's not a golden delicious but its own unique species.

Friends of JOA: P. Harris: We had our annual garden party on July 24th and we had a good gathering. We're planning on having another board retreat in October.

Pat wanted some clarification on the May 18th minutes from Brent for the following sentence: "We all [staff and board members]want tours coming out to the Arboretum, we just need to legitimize it and make it legal—use it to the advantage of the Arboretum to help support it as long as it does not hurt the Arboretum."

I spoke to Brent today while he was in the office and this is what he said:

"We want people to come to the Arboretum to fulfill Caroline's mission to educate. If you (the Board), decide to proceed with tours at the Arboretum, then it must abide by the Conservation Easement. For example, no commercial activities that would require a permit. So if the Arboretum was to offer a tour by a docent, that is approved by SEAL Trust, then that would not require a permit. Tours should only be offered if it benefits the Arboretum and not be a burden."

Manager's Report to the Advisory Board

November 9, 2016

- Participated with GLORIA field work; plot sites selected on Blackerby Ridge
- Articles written and photos submitted for the American Primrose Society's Quarterly and Horticulture Magazine
- FJOA wine tasting and fundraiser was a success
- Materials supplies to Parks & Recreation for information board to be uses in P & R master planning
- Carrie's last day of the season was September 17th. She plans on returning next April
- Seed harvested, cleaned and sent to the North American Rock Garden Society (NARGS) and American Primrose Society (APS) seed exchanges. We are APS's largest donor in both number of species (35) and amount of seed.
- Re-worked the stone path from the garage past the residence. 30' of stone removed and new grass seeded in an attempt to re-direct traffic back toward the garden's more desirable views.
- Mapping work continues with UAS intern
- Research materials collected (plant tissues and seed), prepared and sent to universities in Bergen and Oslo, Norway and Paris, France.
- Fall bulbs planted
- Chilkat View shelter finally completed and landscaped (70 new plants and 350 bulbs). CBJ Landscape crew assisted with final D1, soil and wood chip hauling.
- Met with Juneau School District personnel to work on classroom visitation policies
- Fall clean up and pruning
- Early snow on October 16th. 8" of heavy, wet snow caused some damage to trees. I was out every 2 hours the entire day shaking snow off plants to prevent major damage
- Attended the 3 day annual Alaska Invasive Species workshop in Fairbanks in late October
