1.2 **Scope of Services**

The Consultant shall provide all necessary profession services, including but not limited to, research, engineering, surveying and design services to prepare complete, bid-ready construction drawings, specifications, bid schedule and engineer's estimate for construction, including outreach and coordination assistance with the neighborhood residents, for the reconstruction of Calhoun Avenue from the Gold Creek Bridge to West Seventh Street.

The scope of construction work includes: Replacement of road base and structural section, drainage and underground water and sewer utilities improvements and new asphalt paving. In addition work will include new curb and gutter and sidewalk installations and miscellaneous other improvements necessary for a complete project.

The site of the work is Calhoun Avenue from Gold Creek Bridge to West Seventh Street, in Juneau, Alaska.

A second phase of work may be added to the contract at a future date by amendment upon successful completion of the initial work requested above. This work would be for design and other necessary services to prepare bid ready documents for the resurfacing of Calhoun Avenue from West Seventh Street intersection to Main Street.

Proposers should address only the scope of the work identified for Calhoun Avenue between Gold Creek and West Seventh in their submittal. Proposals will only be evaluated based on the information provided for this scope of work.
