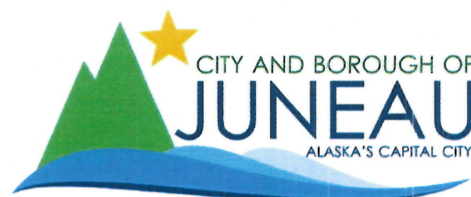
The bid from Rock Bottom Enterprise, LLC, has been deemed non-responsive due to not meeting the bid security requirement.
