RE:	City & Borough of Juneau COVID-19 Response – Emergency Operations Center Update

Situational Update – Incident Level 2 - Operational Period 18 (7/23/2020 – 8/6/2020).

Disease Transmission/Contact Tracing:

The state is reporting 61 new statewide resident cases and 19 new statewide non-resident cases. Within these numbers, 3 resident and 1 non-resident cases are attributed to Juneau.

The CBJ EOC numbers differ from the state dashboard due to more timely reporting. Locally, we are reporting 2 resident and one less nonresident cases. This is because the state moved one of the nonresident cases to resident status. There are a total of 15 active cases in the community.

AGS: To date, AGS has a total of 66 positive cases – 15 are residents, 51 are nonresidents.

DPH reports they are tracking 22 PUIs. AGS continues to monitor 42 employees as close contacts.

Testing:

Staff and collection supplies have episodic interruptions, but test results continue to come in generally in the 3-6 day range. 95 test results were received yesterday, 89 of which were collected on July 30^{th} . The remaining tests were collected between July 27^{th} through July 29^{th} .

Hospital Response:

BRH reports adequate supply of PPE and no concerns related to workforce availability.


Issues of Note:

- We expect to hear more information by midweek on the changes to Health Mandate 10.





Acquisition of COVID-19

This chart tracks the number of new cases in the past 7 days, controlled for population. Other than Alaskan boroughs, King County (Seattle) and Multhomah County (Portland) are included for context and due to travel frequency.

The source data for Alaska is from the SOA dashboard. Out of state data is from the Harvard Global Health Institute (<u>https://globalepidemics.org/key-metrics-for-covid-suppression/</u>) and is generally lags a day behind most of our other reporting.
