RE: City & Borough of Juneau COVID-19 Response – Emergency Operations Center Update

Situational Update – Incident Level 2 - Operational Period 18 (7/23/2020 – 8/6/2020).

Disease Transmission/Contact Tracing:

The state is reporting 59 new statewide resident cases and 7 new statewide non-resident cases. Within these numbers, 1 resident and 0 non-resident cases are attributed to Juneau.

The CBJ EOC numbers differ from the state dashboard due to more timely reporting. Locally, we are reporting 5 resident and 3 nonresident cases. There are a total of 16 active cases in the community.

Of the cases reported today, 2 are travel related (1 resident & 1 nonresident), 3 are secondary transmission related to the AGS cluster (1 resident & 2 nonresident), and the remaining cases are connected and under investigation as to disease acquisition source. DPH has not updated their PUI count connected to the new cases.

AGS: To date, AGS has a total of 69 positive cases – 16 are residents, 53 are nonresidents.

Testing:

Staff and collection supplies have episodic interruptions, but test results continue to come in generally in the 3 – 6 day range. 45 test results were received yesterday which were collected on July 30th and 31st, 3 – 4 days after collection.

Hospital Response:

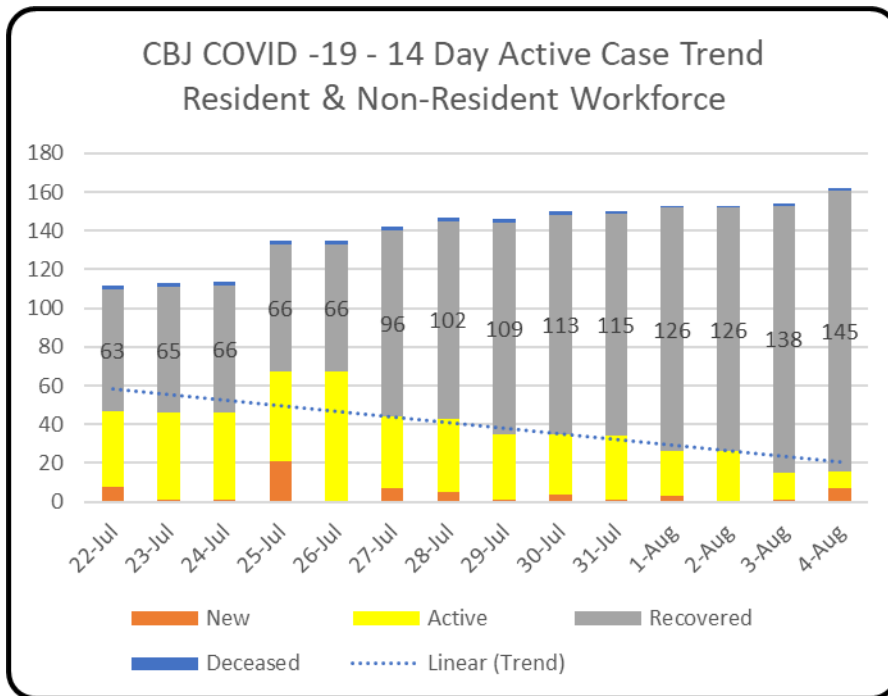
BRH reports adequate supply of PPE and no concerns related to workforce availability.

Issues of Note:

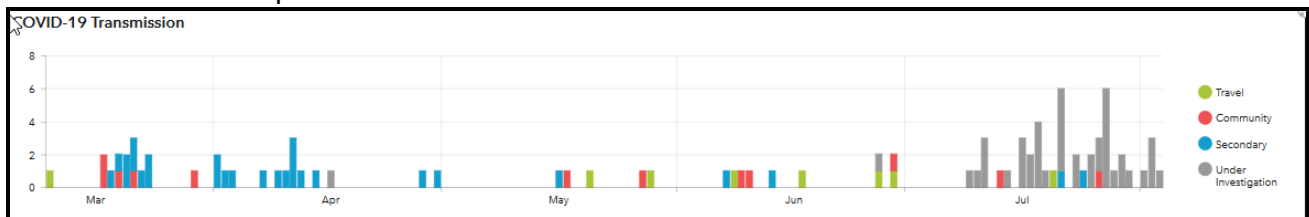
- The State published their new dashboard today. We've included one new graphic: Disease Acquisition for Nonresident population. The CBJ EOC is reviewing and determining how it will impact our reporting.
- The Governor is holding a press conference tonight about Health Mandate 10. We expect to have a better idea of operational impact tomorrow.
- The EOC continues to work on the risk matrix and community mitigation measures.
- Cloth face coverings will be distributed in the community this Thursday and Friday at various points around the community. A press release with details was sent out.

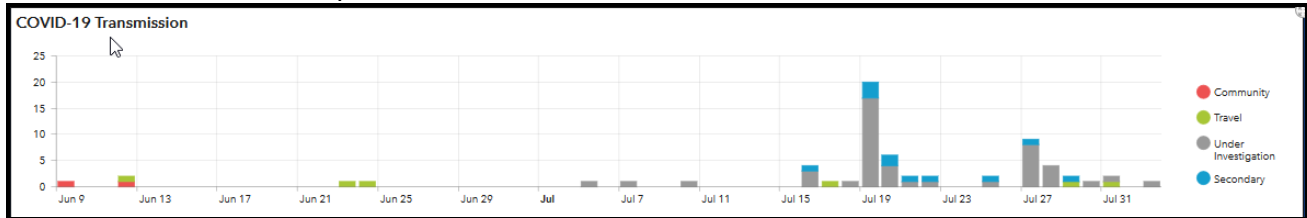


Resident Disease Acquisition

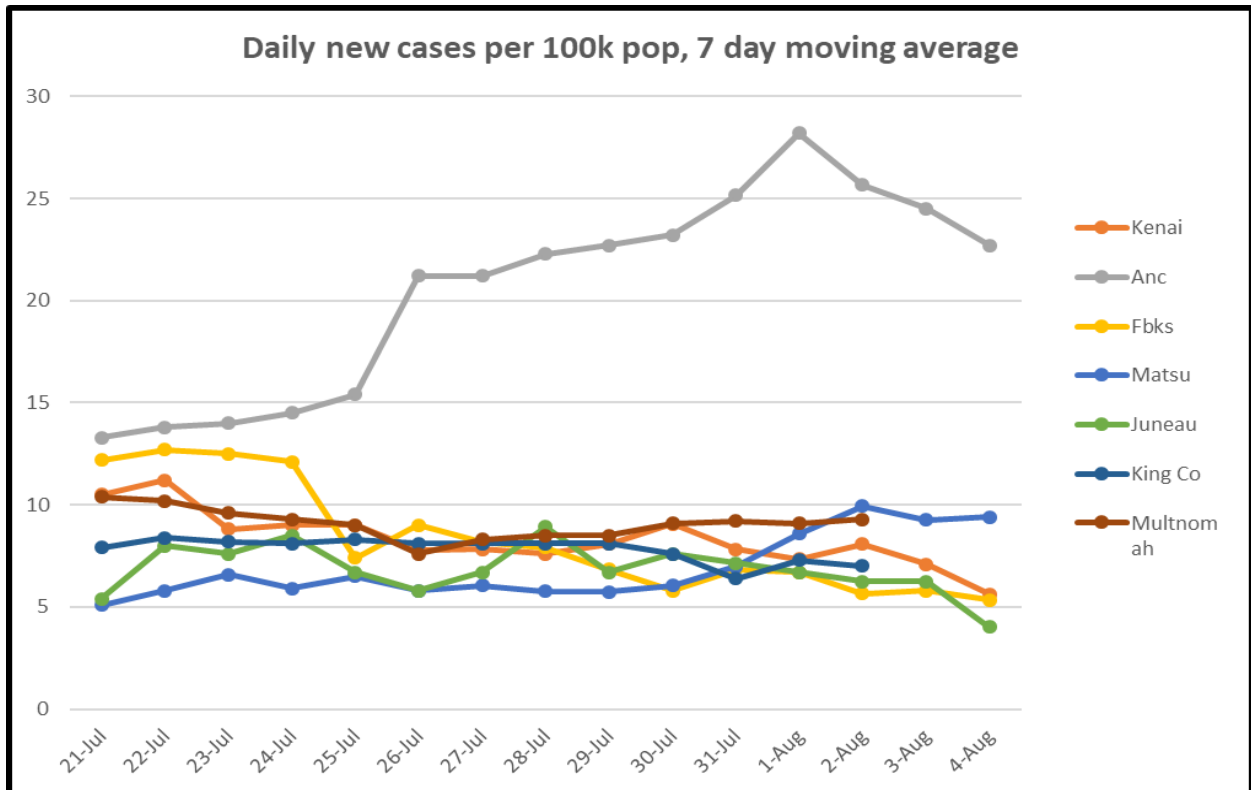

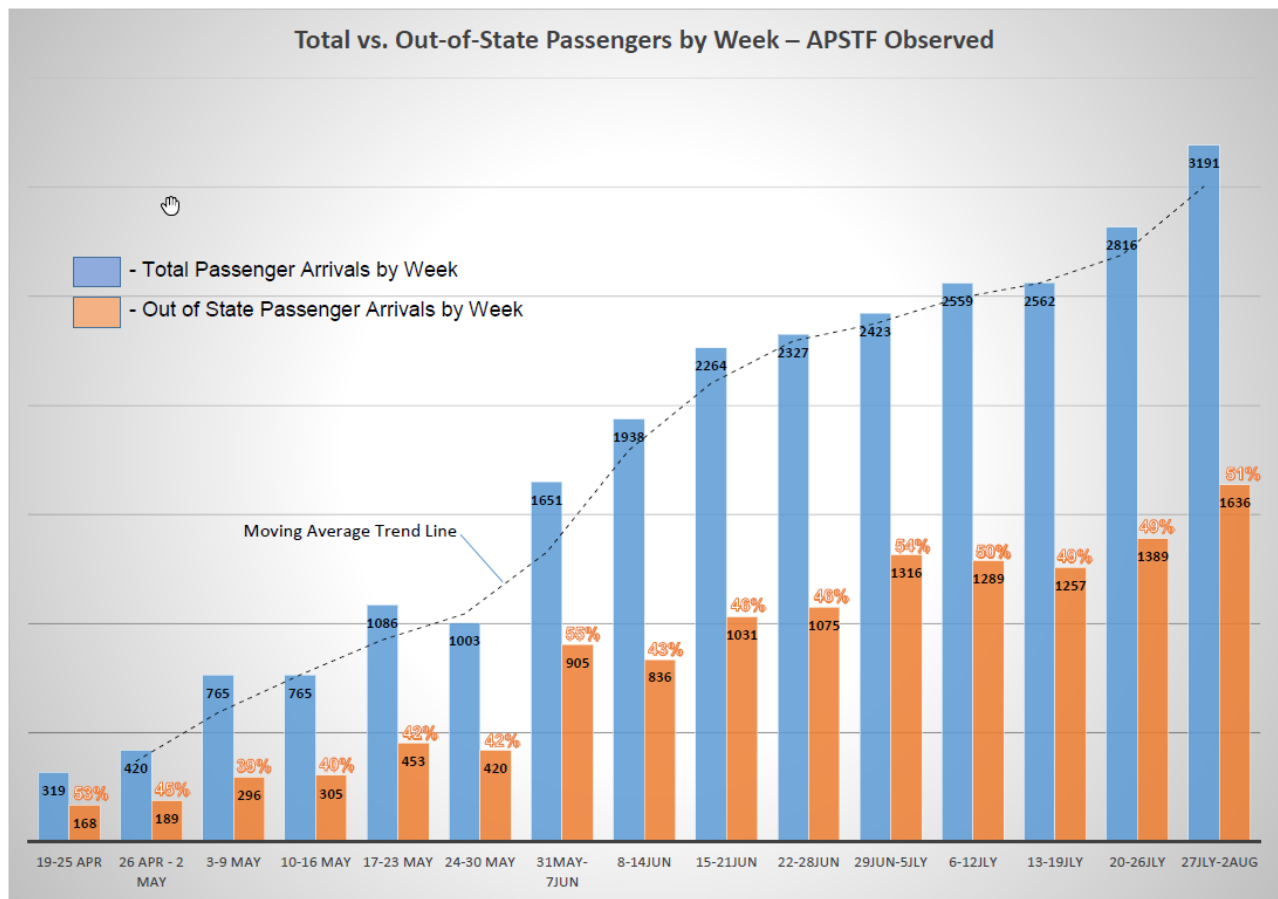
