RE: City & Borough of Juneau COVID-19 Response – Emergency Operations Center Update

Situational Update – Incident Level 2 - Operational Period 18 (7/23/2020 – 8/6/2020).

## <u>Disease Transmission/Contact Tracing:</u>

The state is reporting 59 new statewide resident cases and 7 new statewide non-resident cases. Within these numbers, 1 resident and 0 non-resident cases are attributed to Juneau.

The CBJ EOC numbers differ from the state dashboard due to more timely reporting. Locally, we are reporting 5 resident and 3 nonresident cases. There are a total of 16 active cases in the community.

The cases reported today are under investigation.

UnCruise: There are four close contacts associated with the positive case from the UnCruise vessel. All guests have been taken to a hotel where they are quarantining. Meals will be delivered to guests and security has been engaged to assure compliance. Follow up testing protocols are being established now.

#### Testing:

Staff and collection supplies have episodic interruptions, but test results continue to come in generally in the 3-6 day range. 173 test results were received yesterday which were collected on July  $30^{th}$  and August  $1^{st}$ , 3-5 days after collection. The majority of the tests (113) were from July  $31^{st}$ . 58 were from August  $1^{st}$ 

### **Hospital Response:**


BRH reports adequate supply of PPE and no concerns related to workforce availability.

#### **Issues of Note:**


- HM10 is still scheduled to go live on August 11. Working with the State EOC on implementation
  details. We expect to have a written policy document/FAQ by tomorrow. We believe that voluntary
  intrastate travel testing will be available. In addition, the state is rolling out an app based system for
  registering and tracking travelers. This should provide more efficient and hopefully timely
  information sharing.
- BRH is out of Cepheid test kits. They do have a back up that is less desirable. At present, rapid testing kits are primarily used when they are unable to get test results back in a 72 hour timeframe.
- The EOC continues to work on the risk matrix and community mitigation measures.
- Cloth face coverings will be distributed in the community this Thursday and Friday at various points around the community. A press release with details was sent out.




