**Situation Assessment:** We are experiencing a high volume of new cases, a significant number of which are attributed to community spread. Our 14 day and 7 day case rate indicators are at the high alert level. The community is urged to take appropriate cautions and in particular to refrain from indoor, unmasked activities with individuals outside of family/social bubbles

## **Issues of Note:**

Test results are beginning to return from the pop up testing event – it appears that most of Friday has returned and we are beginning to see results from Saturday the 12<sup>th</sup>. Of the 683 tests taken at Centennial Hall, 404 have returned.

Commercial air passenger counts continue to drop. Trended passenger counts are provided at the end of this report.

## **Daily Numbers Report:**

We are reporting 13 new cases today.

## <u>Disease Transmission/Contact Tracing:</u>


There are 13 new resident and no nonresident cases reported for Juneau today. Of the 13 cases reported, 4 are secondary transmission cases associated with the large event/bar outbreak, 1 is a secondary transmission case unassociated with the outbreak, and the remaining 9 are under investigation. CBJ is showing a higher number of both resident and nonresident cases than what is reported on the state dashboard. In addition, our recovered numbers continue to be larger than what is being reported by the state. Both discrepancies are due to more timely local reporting.


The State of Alaska is reporting 43 new cases today bringing the statewide cumulative case count to 7,313.

## Testing:

9/12/20: 35 test results were received ranging in collection dates from 9/8/2020 - 9/9/2020. This represents a 3 - 4 day turn around time.

9/14/20: 67 test results were received collected on 9/10/2020. Tests were returned in 4 days.





This chart tracks the number of new cases in the past 7 days, controlled for population. King County (Seattle) and Multnomah County (Portland) are included for context and due to travel frequency. The source data for Alaska is from the SOA dashboard. Out of state data is from the Harvard Global Health Institute (https://globalepidemics.org/key-metrics-for-covid-suppression/) and generally lags a day behind most of our other reporting.
