 RE: **Situational Update –Level 3 High-** Operational Period 26 (11/12/2020 – 12/3/2020)

Situation Assessment: Our 7 and 14 day case rate indicators are in the very high alert level range. The disease is moving via travel and family groupings. Contact tracing is impaired due to caseloads statewide and the nature of contacts required. Residents must take appropriate cautions, including limiting social bubbles to immediate family members.

Issues of Note:

Cases continue to climb around the state – today DHSS reported 551 new cases. Anchorage hospitals are near capacity. BRH reports they are still able to medevac if necessary.

At UAS, there are currently 8 COVID positive cases (7 in town, 1 out of town). 2 cases have recovered. One new positive was identified through the testing on Tuesday. We will do another round of testing next week.

DHSS reverted back to their old methodology of reporting case trends. We have updated the graph.

Daily Numbers Report:

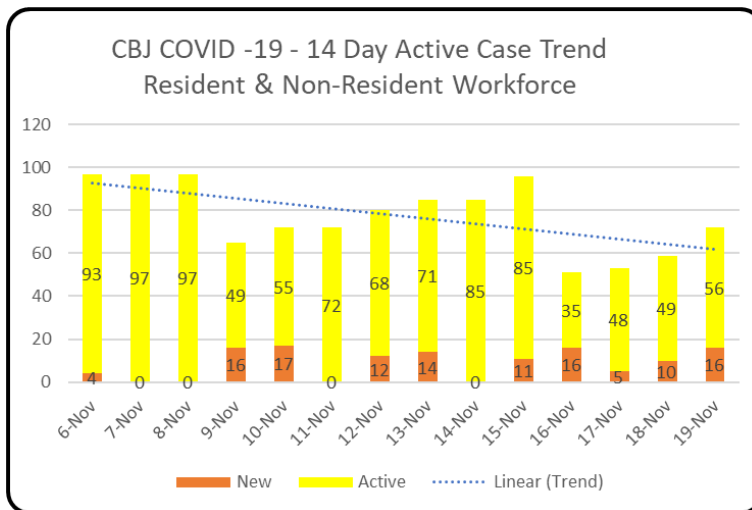

Disease Transmission/Contact Tracing:

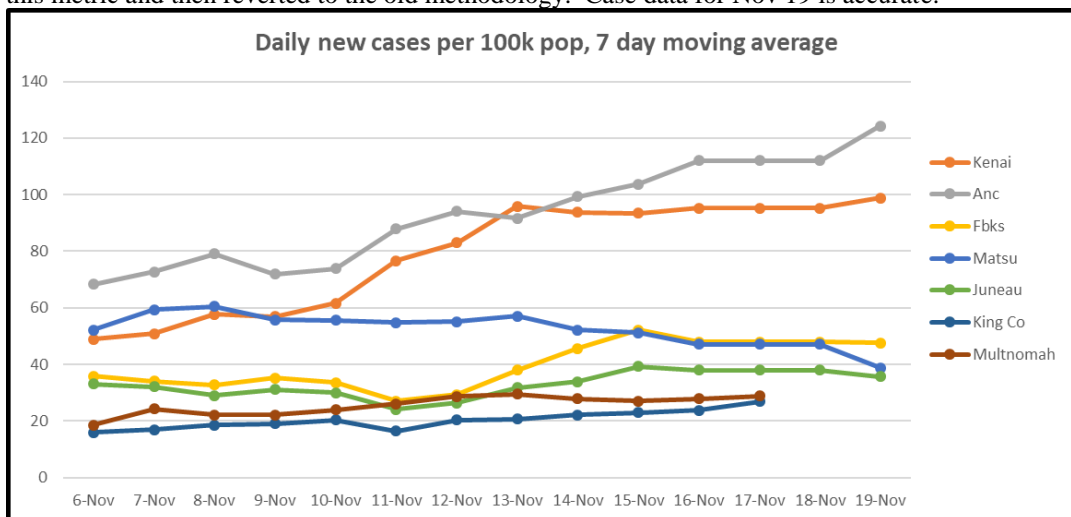
We are reporting 16 new resident cases and no new nonresident cases today: 4 are secondary transmission, 1 is travel related, and the remaining cases are under investigation.

The State of Alaska is reporting 505 new cases today bringing the statewide cumulative case count to 26,081.

Testing: 138 test results were received from the Fulgent Lab with collection dates of 11/14/2020 – 11/16/2020, returning results to individuals 2-4 days after collection. No test results were received from the Alaska State Lab.



Please note: new case report data below for Nov 17 and 18 is the same as Nov 16. The state changed their reporting on this metric and then reverted to the old methodology. Case data for Nov 19 is accurate.



This chart tracks the number of new cases in the past 7 days, controlled for population. King County (Seattle) and Multnomah County (Portland) are included for context and due to travel frequency. The source data for Alaska is from the SOA dashboard. Out of state data is from the Harvard Global Health Institute (<https://globalepidemics.org/key-metrics-for-covid-suppression/>) and generally lags a day behind most of our other reporting. Policy recommendations at varying levels (<1, <10, <25, 25+) can be found on their website
