**Port Director's Corner:** On November 10th, Docks & Harbors and our local consultants provided an overview of the Small Cruise Ship Infrastructure Master Plan (SCSMP) with the goal of soliciting feedback from the public. One can find the relevant documents and video of the presentation at:

<https://tinyurl.com/Small-Cruise-Ship-Study> . As discussed in the public meeting there is much work to be accomplished before any large infrastructure project is realized. The Docks & Harbors Board will consider adopting the plan at a future Board meeting, the Assembly will be briefed most likely at a Committee of the Whole (COW) meeting early in 2021. It is important to note that funding is yet to be secured, final design efforts have not been solicited and permitting has not commenced. Generally speaking, major investments take several years but I am fond of telling my staff...“a job once started is half done.”

**Norwegian Cruise Lines (NCL) Dock:** A companion project to our SCSMP, but not formally connected, is NCL's efforts to construct a new port facility at their property at the Subport Lot. NCL is also soliciting public comment and has arranged several Zoom meetings. The first meetings were on November 18th and December 2nd with another proposed for December 28th. **Visitor Industry Task Force DRAFT Recommendations:** In October 2019, Mayor Weldon appointed Assembly member Carole Triem to lead a community task force to evaluate the impacts of tourism within the community. The Visitor Industry Task Force completed their draft report on April 27th, 2020 after months of public meetings, public input and deliberations from the ten member panel. Although Docks & Harbors actively monitored the progress, it was not officially a member of the working group. In July, the Docks & Harbors Board stood up a special committee to review the DRAFT recommendations and has commented on topics which touch jurisdictional areas of the department.

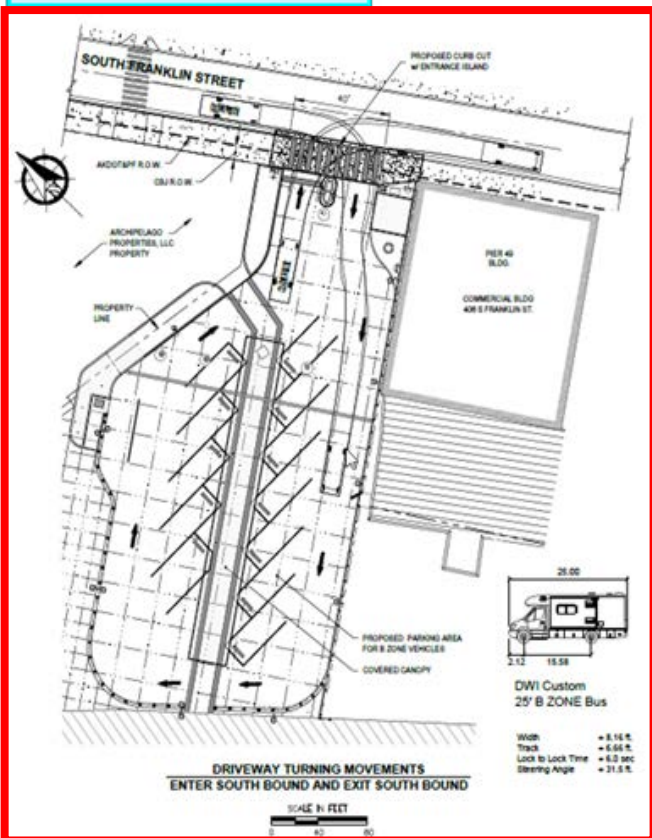

Public Hearing on Regulation Change to 05 CBJAC 20.044 - Active fishing vessel discount at Statter Harbor. The Docks & Harbors Board will hold a public hearing at its December 17th regular Board Meeting via Zoom. The proposed change will add paragraph (c) to <https://tinyurl.com/Commercial-Fishing-Discount> which is proposed to read:

*(c) Reciprocation. Fishing vessels maintaining reserved moorage in Statter Harbor will be allowed 20 days at the downtown harbors during the calendar year provided they comply with the stipulations above.*

New Archipelago Bus Staging Lot - new ordinance defining "B Zone" transportation vehicles. Docks & Harbors has started a process to change the regulation defining "B Zone" as a vehicle carry less than 18 passengers to a vehicle which is 25 feet in length or less. The need for this regulation change is due to our design efforts to maximize the size of small busses which will be able to use the new Archipelago Bus Staging area. Because of the tight turning requirements egressing/exiting onto South Franklin Street, we were able to design for a 25 foot bus which will typically carry more than 18 passengers.
