#### **Election Statistics:**

The October 6, 2020 CBJ Regular Municipal Election was conducted "By-Mail." The total number of registered voters in the City and Borough of Juneau was 27,789 and 11,875 ballots were counted in the election. Voter turnout was 42.7 %.

CBJ partnered with the Municipality of Anchorage for use of their Election Center and staff to assist in processing the ballots. Ballots were received via USPS Mail at a P.O. Box in Anchorage, at two Vote Centers located at City Hall and at the Mendenhall Library, via fax/e-ballot, and in two Ballot Drop Boxes located at the Douglas Library and in the Statter Harbor Boat Launch parking lot. The Municipality of Anchorage Ballot Review team, with oversight by the CBJ Election Official, and the Canvass Review Board located in Juneau provided additional review of those ballots that did not pass the initial ballot review protocols. Of the ballots 629 ballots requiring additional review, 108 ballots were rejected for the following reasons: 32 signature cure challenges not satisfied, 11 questioned ballots were deemed ineligible due to late registration or not meeting Juneau voter registration requirements, and 65 ballots were received with no discernable postmarked or postmarked after election day, Oct. 6, 2020.

For comparative purposes with previous elections, the ballots were coded to enable reporting to be split out according to in person precincts based on voter registration data as listed below:

### NOTICE OF REGULAR MUNICIPAL ELECTION - OCTOBER 6, 2020

Notice is hereby given that the Regular Municipal Election will be held in the City and Borough of Juneau, Alaska on **Tuesday**, **October 6**, **2020 by-mail**. Precinct polling places will not be available for regular in-person voting on election day.

Registered voters of the State of Alaska who reside within the City and Borough of Juneau are eligible to vote in this election and will be mailed a ballot at the permanent mailing address listed in the State of Alaska Voter Registration List. Voters should be prepared to provide identification along with their voted ballot if no identification was filed with the State of Alaska when registering.

### The purpose of the election is:

- 1. To elect from candidates residing in the entire City and Borough of Juneau, one Areawide Assemblymember for a term of three years;
- 2. To elect from candidates residing in Election District No. 1, one Assemblymember for a term of three years;
- 3. To elect from candidates residing in Election District No. 2, one Assemblymember for a term of three years;
- 4. To elect from candidates residing in the entire City and Borough of Juneau, two members of the Board of Education (School Board) for terms of three years each.
- 5. To vote on the following two (2) areawide propositions:

The City and Borough of Juneau Charter Provides that every ten years subsequent to 1970 the clerk shall place on the ballot for the next regular election the question: "Shall there be a Charter Commission to review or amend the Charter?" The proposition will authorize the issuance of \$15,000,000 in general obligation bond debt for paying the cost of planning, design and construction of municipal infrastructure, facilities and related capital improvements, including school roof replacements, municipal park improvements, street repairs, and energy efficiency building maintenance projects. The total annual debt service costs, assuming an interest rate of 3.5%, will be \$857,000. This amount of debt service would require an annual property tax levy of approximately \$16.75 per \$100,000 of assessed value. ### NOTICE OF BOND ELECTION

City and Borough of Juneau Outstanding and Other Debt Information

The following information is provided as required by CBJ Charter Section 10.5, Notice of Bond Election:

- CBJ's total general obligation outstanding debt, as of September 1, 2020, is \$66,636,500. Of this amount, it is possible that \$0 will be reimbursed by the State of Alaska under the State's School Construction Bond Debt Reimbursement Program. The school debt issued is eligible for 60-70% debt reimbursement from the State, subject to annual appropriation by the Legislature.
- There are no unissued voter approved general obligation bonds.
- For the current fiscal year, FY21, CBJ is budgeting to pay a total of \$15,509,000 for bond debt service (both principal and interest). \$0 of this amount is anticipated to be reimbursed by the State under the State's School Construction Bond Debt Reimbursement Program. This leaves a balance of \$15,509,000 to be paid from

local tax sources and interest income. Of this amount, \$2,095,000 will be paid from port development revenues and fund balance from the Port Development Fund, \$602,000 from the Airport Enterprise Fund, \$6,135,000 from general property tax levies, and \$6,677,000 will be paid with fund balance from the Debt Service and General Funds.

- The current total taxable assessed valuation within the municipality is \$5,117,034,000 (\$5.12 billion).
- The maximum interest rate to be paid on this bond will vary depending on the market conditions at the time of issuance. CBJ anticipates that the effective interest rate on the general obligation tax exempt bonds will not exceed 3.5%.

### ORDINANCE OF THE CITY AND BOROUGH OF JUNEAU, ALASKA

Serial No. 2020-40(b)(am)

An Ordinance Authorizing the Issuance of General Obligation Bonds in the Principal Amount of Not to Exceed Fifteen Million Dollars to Finance Capital Improvements to the Facilities of the City and Borough, and Submitting a Proposition or Propositions to the Voters at the Election to Be Held Therein on October 6, 2020.

WHEREAS, improvements and renovations to the infrastructure and facilities of the City and Borough of Juneau, Alaska (the "City and Borough") are needed in order to meet the current and future needs of the City and Borough; and

WHEREAS, the COVID-19 epidemic has placed unprecedented strain on the Juneau economy; and

WHEREAS, strained municipal revenues have caused certain public infrastructure projects to be delayed for lack of current funding; and

WHEREAS, economic stress and uncertainty has caused businesses to delay infrastructure projects that would have generated local economic activity; and

WHEREAS, history has demonstrated the economic stabilization and recovery benefits that accrue from public infrastructure spending in times of economic stress; and

WHEREAS, a number of school facilities are in urgent need of roof and facility repairs that have been deferred due to lack of funding; and

WHEREAS, the Parks and Recreation Department has worked with the community to develop detailed master plans to repair and improve specific parks, playgrounds, and other infrastructure that has reached the end of its useful life, yet remain unbuilt because of a lack of funding; and

WHEREAS, maintenance and improvement of surface transportation routes provides a long-term benefit for residents and businesses; and

WHEREAS, energy efficiency building maintenance projects can reduce future expenditure on heating fuel and electricity and reduce greenhouse gas emissions; and

WHEREAS, certain projects listed in Section 3 below (the "Projects") have been identified and approved by the Committee of the Whole as necessary to meet the needs of the City and Borough; and

WHEREAS, in order to provide funds for paying the cost of acquiring, constructing, renovating and equipping the Projects, it is deemed necessary and advisable that the City and Borough issue and sell its unlimited tax levy general obligation bonds in the principal amount of not to exceed \$15,000,000 (the "Bonds");

Now, Therefore, Be it Enacted by the Assembly of the City and Borough of Juneau, Alaska:

- **Section 1. Classification.** This ordinance is a noncode ordinance.
- **Section 2. Findings.** The Assembly of the City and Borough hereby finds and declares that the acquisition, construction, renovation and equipping of the Projects identified in Section 3 hereof are necessary and are in the best interest of the inhabitants of the City and Borough.
- **Section 3. Purposes.** The Assembly has determined that the City and Borough is in need of the following:
  - Critical school roof repairs/replacements and other critical school repairs;
  - Repairs and capital improvements to municipal park infrastructure and recreation facilities; and
  - Repairs and capital improvements to municipal infrastructure, specifically city streets and energy efficiency building maintenance projects.

The foregoing are herein referred to as the "Projects." The cost of all necessary architectural, engineering, design, and other consulting services, inspection and testing, administrative and relocation expenses, costs of issuance of the Bonds and other costs incurred in connection with the Projects that is approved by the electors shall be deemed capital improvement costs of the approved Projects. The approved Projects may be completed with all necessary furniture, equipment and appurtenances.

If the City and Borough shall determine that it has become impractical to accomplish any portion of the approved Projects by reason of changed conditions or needs, incompatible development or costs substantially in excess of those estimated, the City and Borough shall not be required to accomplish such portions and shall apply Bond proceeds as set forth in this section.

Interest earnings on Bond proceeds may be used and applied by City and Borough, at the direction of the City Manager or his or her designee, for the Projects or for other capital improvements or for the retirement of the Bonds or other general obligation bonds of the City and Borough.

If the approved Projects have been completed in whole or in part, or its completion duly provided for, or its completion found to be impractical, the City and Borough may apply Bond proceeds or any portion thereof as provided in Section 10.10 of the Home Rule Charter.

In the event that the proceeds of sale of the Bonds, plus any other monies of the City and Borough legally available, are insufficient to accomplish the approved Projects, the City and Borough shall use the available funds for paying the cost of those portions of the approved Projects for which the Bonds were approved deemed by the Assembly most necessary and in the best interest of the City and Borough. No Bond proceeds shall be used for any purpose other than a capital improvement.

**Section 4. Details of Bonds.** The Assembly hereby authorizes the issuance of general obligation bonds in order to fund the costs of the Projects described in Section 3 (the "Bonds"). The Bonds shall be sold in such amounts and at such time or times as deemed necessary and advisable by the Assembly and as permitted by law and shall mature over a period of up to 25 years of date of issue. The Bonds shall be issued in an aggregate principal amount of not to exceed \$15,000,000. The Bonds shall bear interest to be fixed at the time of sale or sales thereof. Both principal of and interest on the Bonds shall be payable from annual tax levies to be made upon all of the taxable property within the City and Borough, without limitation as to rate or amount and in amounts sufficient with other available funds, to pay such principal and interest as the same shall become due.

The full faith, credit, and resources of the City and Borough are hereby irrevocably pledged to the payment of both the principal and interest on such Bonds. The exact form, terms, conditions, contents, security, options of redemption, and such other matters relating to the issuance and sale of said Bonds as are deemed necessary and advisable by the Assembly shall be as hereinafter fixed by ordinance and resolution of the City and Borough.

**Section 5. Submission of Question to Voters.** The Assembly hereby submits to the qualified electors of the City and Borough the proposition or propositions of whether or not the City and Borough should issue the Bonds for the purpose of financing the costs of the approved Projects at the regular municipal election to be held on October 6, 2020.

The City and Borough clerk shall prepare the ballot proposition(s) to be submitted to the voters as provided by this ordinance and shall perform all necessary steps in accordance with law to place these propositions before the voters at the regular election.

**Section 6. Ballot Proposition.** The proposition(s) to be submitted to the qualified voters of the City and Borough as required by Section 5 above shall read substantially as follows:

#### **Explanation**

The proposition will authorize the issuance of \$15,000,000 in general obligation bond debt for paying the cost of planning, design and construction of municipal infrastructure, facilities and related capital improvements, including school roof replacements, municipal park improvements, street repairs, and energy efficiency building maintenance projects. The total annual debt service costs, assuming an interest rate of 3.5%, will be \$857,000. This amount of debt service would require an annual property tax levy of approximately \$16.75 per \$100,000 of assessed value. This example of a property tax levy is provided for illustrative purposes only.

### PROPOSITION NO. \_\_\_ GENERAL OBLIGATION BONDS

**Section 7. Notice of Election.** The Assembly shall cause a notice of election to be published once a week for three consecutive weeks in a newspaper for general circulation in the City and Borough. The first notice shall be published not later than September 16, 2020, which is 20 days prior to the regular municipal election. The notice shall contain the information required by Section 10.5 of the Home Rule Charter of the City and Borough.

#### **Section 8. Effective Dates.**

(a) The authority to issue general obligation bonds proposed in Section 6 of this ordinance shall become effective on the day following the date the election results are certified for the regular municipal election held on October 6, 2020, if a majority of the qualified voters voting on the proposition set forth in Section 6 votes for the proposition.

(b) Section 6 of this ordinance authorizing the submission of the ballot proposition to the qualified voters of the City and Borough shall become effective thirty days after adoption of this ordinance.

## Notice of Regular Municipal Election

Notice is hereby given that the Regular Municipal Election will be held in the City and Borough of Juneau, Alaska, on Tuesday, October 6, 2020, by mail. Precinct polling places will not be available for regular in person voting on election day. Registered voters of the State of Alaska who reside within the City and Borough of Juneau are eligible to vote in this election and will be mailed a ballot at the permanent mailing address listed in the State of Alaska Voter Registration List. Voters should be prepared to provide identification along with their voted ballot if no identification was filed with the State of Alaska when registering.

## The purpose of the election is:

- 1. To elect from candidates residing in the entire City and Borough of Juneau, one Areawide Assemblymember for a term of three years;
- 2. To elect from candidates residing in Election District No. 1, one Assemblymember for a term of three years;
- 3. To elect from candidates residing in Election District No. 2, one Assemblymember for a term of three years;
- 4. To elect from candidates residing in the entire City and Borough of Juneau, two members of the Board of Education (School Board) for terms of three years each.
- 5. To vote on two areawide propositions.
  - a. Proposition No. 1 Charter Commission Question
  - b. Proposition No. 2 General Obligation Bonds

## WHAT'S NEW WITH THE 2020 ELECTION?

Due to COVID-19, the Juneau Assembly voted in May 2020 to hold the October 6 2020 Regular Municipal Election "By-Mail." All voters registered at a residence address in the City and Borough of Juneau by September 6, 2020, will be mailed a ballot at the permanent mailing address on file with the State of Alaska's Division of Elections.

We appreciate the Municipality of Anchorage (MOA) allowing us to use their election center equipment and to receive assistance from their staff for conducting this by-mail election.

## How will this election process work? Initial Mailing

• Ballots will be mailed to each Juneau registered voter on September 15, 2020, or to a temporary address through September 29 for applications received between September 6 and 29.

## **Voting Methods**

- Voters will receive their ballot package containing the official ballot, secrecy sleeve with an "I Voted" sticker, and a return ballot envelope.
- The voter marks their ballot, places it in the secrecy sleeve (removing the sticker), seals it in the return ballot envelope, signs the envelope in the presence of a witness who is at least 18 years of age, and has the witness sign the envelope.
- The voter then returns the ballot using one of the following methods:

  A. Places a .55 cent stamp on the envelope and returns it via USPS mail (ballots postmarked by Election Day, October 6 and received prior to final review on October 20 will be eligible to be counted), or

  B. Drops the sealed voted ballot envelope in one of the two CBJ ballot drop boxes no later than 8:00 p.m. on October 6, 2020, or

  C. Brings their ballot to one of CBI's two vote centers during vote

center hours or obtains a replacement ballot at one of the vote centers.

## **Ballot Review and Results**

- Return ballots sent through the US Postal Service are being mailed to a CBJ PO Box located in Anchorage and will be picked up with the beginning stages of review conducted by Municipality of Anchorage election staff.
- Ballots returned at the CBJ vote centers and through the ballot drop boxes will be collected, batched, and go through a preliminary review process in Juneau and to ensure voter signatures and witness signatures are on the envelopes.

## WHAT'S NEW WITH THE 2020 ELECTION?

- Following the close of the polls at 8:00 p.m. on Election Day, October 6, CBJ election staff will collect and batch all ballots received in Juneau and will fly up to Anchorage with those ballots to begin the review and preliminary counting process.
- Ballots received and reviewed by Friday, October 9 will be counted that day.
- Ballots will NOT be counted on Election Day and the earliest preliminary results will be posted on our website on Friday, October 9.
- Ballot review and the signature verification process will take place between September 21 and October 20. Voters may receive follow-up requests from election officials related to the signature verification process during this time frame.
- Final results will be made available after the CBJ Canvass Review Board conducts its review of the election on Tuesday, October 20. This work may be continued from day to day for up to three days depending on the volume of ballots/review required of the Canvass Board.

Ballots are non-forwardable, so if you will be away from your permanent mailing address, you may request that a ballot be sent to a temporary address by completing the Application to Vote at a Temporary Address (available on our website). These applications must be received by the Municipal Clerk's Office by September 29, 2020; however we encourage submission by September 6, to be included in the first mailing, or as early as possible. If you receive election mail addressed to a former resident at your mailing address or anyone else not a resident of your household, please mark it is "Return to Sender – not at this address" and return it to the post office.

Each outgoing and return ballot envelope will have a barcode uniquely tied to the voter whose name is on the envelope. For this reason, each voter needs to return their ballot in their unique ballot envelope. If a voter did not receive their ballot or needs to obtain a replacement ballot package, one can be issued at one of the vote centers or by calling our Election Call Center at 364-7401. Upon receipt of a replacement ballot, the election review system will only count the first ballot envelope received bearing that unique voter barcode and will prevent any other ballot envelopes with that barcode from being processed.



## PROPOSITION NO. 1 CHARTER COMMISION QUESTION

- Q. What is the purpose of Proposition 1?
- A. The CBJ Charter was ratified by voters in 1970 after three years of work sessions and public hearings by the voter-elected Charter Commission. The Charter, Juneau's "constitution," is the document that establishes the name and the boundaries of the City and Borough of Juneau, sets out the powers and duties of the Assembly and the officers of the city, and lays out the general organization of the city. Only the voters can amend the Charter, and they have approved several amendments since 1970. The Charter also requires that the question "Shall there be a Charter Commission to review or amend the Charter?" be put before the voters every ten years.
- Q. What is the difference between charter amendments on the regular election ballot and the creation of the Charter Commission?
- A. A charter amendment is a very specific change to an identified section of the Charter. A Charter Commission is like a constitutional convention; it is an unrestricted review of the Charter by an elected 9-member Charter Commission.
- Q. What is the next step if voters approve Proposition !?
- A. If Proposition 1 is approved, Charter Amendment Section 14.4 provides that "If a majority of the qualified voters voting on the question vote "yes," nine qualified voters to serve as the Charter Commission shall be chosen at the next regular election or at a special election. The commission members shall be elected on the same basis of representation as assembly members. A vacancy shall be filled by the commission with a qualified voter representing the same area as the vacating member."

The Charter requires the costs, fees, and other expenses of the Charter Commission to be paid by the municipality, and the assembly shall provide compensation for commission members. Amendments proposed by the majority of the commission members must be submitted to the voters for approval.

- Q. What Charter amendments have been on the ballot since the Charter Commission question in 2010?
- A. 2017-14, a Charter amendment regarding competitive bidding and 2014-42, authorizing an empowered aquatics board.

## PROPOSITION NO. 2 GENERAL OBLIGATION BONDS

Authorize General Obligation Bonds to Finance Capital Improvements to the Facilities of the City and Borough of Juneau not to exceed \$15 million.

- Q. What is the purpose of Proposition 2?
- A. Proposition 2 asks voters to approve general obligation bonds in an amount not to exceed \$15 million dollars for the purposes of repairing school facilities and roofs, improving and maintaining park infrastructure and recreation facilities, repairing streets and completing energy efficiency building maintenance projects.
- Q. If approved, what will be the impact on City and Borough property taxes?
- A. Voter approval of this proposition would authorize the issuance of \$15,000,000 in general obligation bond debt for paying the cost of planning, design and construction of municipal infrastructure, facilities and related capital improvements, including school roof replacements, and municipal park improvements, street repairs, and energy efficiency building maintenance projects.

The total annual debt service costs, assuming an interest rate of 3.5%, will be \$857,000. This amount of debt service would require an annual property tax levy of approximately \$16.75 per \$100,000 of assessed value. This example of a property tax levy is provided for illustrative purposes only.

Municipal property tax rates are subject to many factors, particularly in these dynamic times. It is the intent of the Assembly to attempt to feather these proposed debt service costs into the generally declining municipal debt schedule so that the property tax rate can remain flat. Other large economic factors, including the health of the economy and whether the State funds existing school facility debt may make flat property taxes extremely difficult.

Q. What projects would be funded by approval of Proposition 2 and how will they be selected?

## PROPOSITION NO. 2 GENERAL OBLIGATION BONDS

A. <u>School Facility Repairs Including Roof Replacements</u>. The roofs at Gastineau, Dzantik'l Heeni and Riverbend schools are beyond repair and in need of replacement to keep the facilities safe and functional for Juneau's students and teachers.

<u>Park Infrastructure and Recreation Facilities</u>. These projects will address needed repairs and maintenance of Juneau's most heavily used parks and facilities. Projects will be selected from the six-year Capital Improvement Plan and area master plans. They include but are not limited to: improvements to Adair-Kennedy, Capital School, Melvin, Savikko, Cope, and Dimond Parks. Facilities that need maintenance and repair include Treadwell Arena, Eagle Valley Center, and Harmon Rifle Range.

Energy Efficiency Building Maintenance. The six-year Capital Improvement Plan lists a number of deferred maintenance projects that would improve energy efficiency at Borough facilities, thereby reducing greenhouse gas emissions and operational costs. Examples of projects include replacing boilers at aging fire stations, installing modern heating and electrical controls at facilities, and LED lighting upgrades.

<u>City Streets</u>. The six-year Capital Improvement Plan establishes a schedule for reconstructing city streets and associated utility infrastructure. It is the intent of the Assembly to rehabilitate a collector street from this list that serves the general public and will improve the surface transportation network in Juneau.

Economies are for and about people. And for people to able to participate fully in the economy and be in a position to take good care of themselves, their families, and our community, we need schools to provide essential knowledge and skills, and prepare our students to adapt to a changing world.

I have seen real, positive change in my first two terms: more students are completing school, fewer minorities are dropping out, students are better prepared for postsecondary education, and, as a community, we are making important investments in early education and understanding better the rich contributions diversity brings. There is still much to do!

The Board adopted a new Strategic Plan and named Achievement, Relationships, Partnerships and Equity as the pillars of our work going forward. COVID19 is disrupting our lives and making the delivery of high quality education an even bigger challenge. Through this pandemic, we need to keep our sights on our mission: *In Juneau, we partner to provide each student with meaningful, relevant, and rigorous learning experiences in order to graduate diverse, engaged citizens ready for a changing world.*
