Situation Assessment: Our 14 day and 7 day case rate indicators are in the High Alert level. The disease continues to move across all disease acquisition types: community spread, secondary transmission, and travel. A more aggressive strain of COVID-19 has been identified in Alaska. We caution the public to strictly adhere to all health orders related to travel and to continue strict adherence to masking and social distancing when outside your immediate home.

Weekly Summary - 14 day lookback for positive tests collected January 17th - January 31st.

Over the last rolling 14 day period, 57 people tested positive for COVID-19 in the community.

Highlights:

18% of the case activity was associated with a cluster at Wildflower Court. Overall, 10 people tested positive, 2 have recovered. There has been some heightened case activity passing through larger families.


16% of the cases were designated as community spread, 60% of the cases were designated as Secondary Infection, 19% of the cases were associated with Travel, and the remaining 5% of the cases remain under investigation.

Contact tracing is improving with 100% of individuals being contacted within 24 hours of a positive test being returned.


Disease spread is across all age groups, most racial groupings, and is slightly more prevalent in males than females (56%/44%).

Disease Acquisition:

Of the 57 positive cases during the last 14 day period, 9 were identified as community spread, 34 were identified as secondary transmission, 11 were identified as travel related, and 3 remain under investigation.

Issues of Note:

The State of Alaska announced that they would no longer update the COVID dashboard over weekends and holidays. Because the state dashboard provides the data we report over the weekend, CBJ will follow suit. There will no longer be EOC updates over the weekend. If there is a significant event that requires immediate attention, the Assembly will be notified and an information release will be put out for the public.

Vaccine updates: 20% of the Juneau population age 16 and above have been vaccinated with 6% of the population having received their 2nd dose. DHSS reports they believe 62% of the population in Juneau aged 65 and older have received their first dose of vaccine.

Registration for POD 2 opened today. The POD is currently open to healthcare workers and community members 65 years of age and up. Roughly half of the slots filled, leaving about 550+ vaccines available. We anticipate enrollment will continue between now and the event. We need approval from the state to go outside of the current Phase and Tier. We anticipate that conversation will be occurring statewide.

The vaccine for the second dose clinic to be held this weekend arrived today.

The transition from CBJ run airport screening and testing to Capstone screening and testing occurred today. So far so good.

We are reporting 11 new resident cases and no new non resident cases. 7 cases are secondary transmission, 3 are community spread, and 1 is under investigation.


The State is reporting 101 new cases today bringing the statewide cumulative total to 54,459 cases.


Testing:


01/29/21: 119 test results were received from the Fulgent Lab with collection dates between 01/26/2021 – 01/28/2021- 27 tests returned in 1 day, 81 tests returned in 2 days, and 11 tests returned in 3 days.

01/30/21: 42 test results were received from the Fulgent Lab with collection dates between 01/26/2021 – 01/28/2021- 35 tests returned in 2 days, 6 tests returned in 3 days, and 1 test returned in 4 days.

01/31/21: 85 test results were received from the Fulgent Lab with collection dates between 01/28/2021 – 01/29/2021- 54 tests returned in 2 days, and 31 tests returned in 3 days
