Situation Assessment: Our 14 day and 7 day case rate indicators are at the moderate alert level. The community continues to see COVID transmit via community spread, secondary infection, and travel. COVID vaccine distribution is on the rise, which should begin to offer the community some level of protection. The more aggressive variants of COVID-19 have been identified in Alaska. We continue to caution the public to strictly adhere to all travel related rules and to continue strict adherence to masking and social distancing when outside your immediate home.

Issues of Note:

POD 4a is underway and runs through Saturday (3/20). The second dose clinic (4b) will be scheduled for April 5 –11. This clinic is made possible through a cooperative effort with SEARHC. We anticipate 2100 doses will be administrated.

POD 5a is scheduled for Tuesday, March 23rd. 1100 doses of Pfizer will be available. There are no appointments left for this clinic but a waitlist has been established. The second dose clinic (5b) will be held on Tuesday, April 13th.

CBJ will be hosting a Community Forum on Vaccines on Wednesday, March 24th at 5:00 pm. Dr. Zink, Dr. Urata, Ali Gottschlich (DPH), Charlee Gribbon (BRH), and Scott Watts will be panelists. Community members will have a chance to ask their question in advance and through the Q&A function in Zoom. The meeting will be streamed live on Facebook and recorded for future viewing.

We expect April allocations to be announced tomorrow or Monday. Once allocations are finalized, April first dose clinics will also be announced.

Daily Numbers Report: We are reporting 1 new case today.

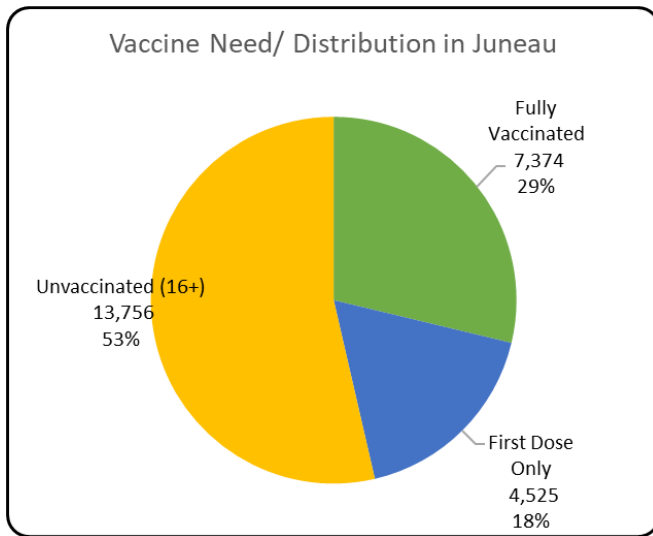

Disease Transmission/Contact Tracing:

We are reporting 1 new resident case and no new nonresident cases today. The new case is community spread.

The State is reporting 157 new cases today bringing the statewide cumulative total to 61,089 cases.

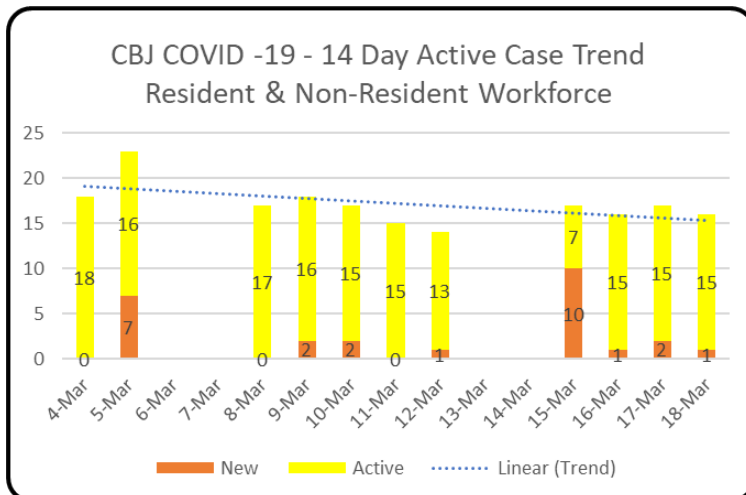
Testing: 35 tests were processed by BRH. Results were provided within 24 hours of testing.

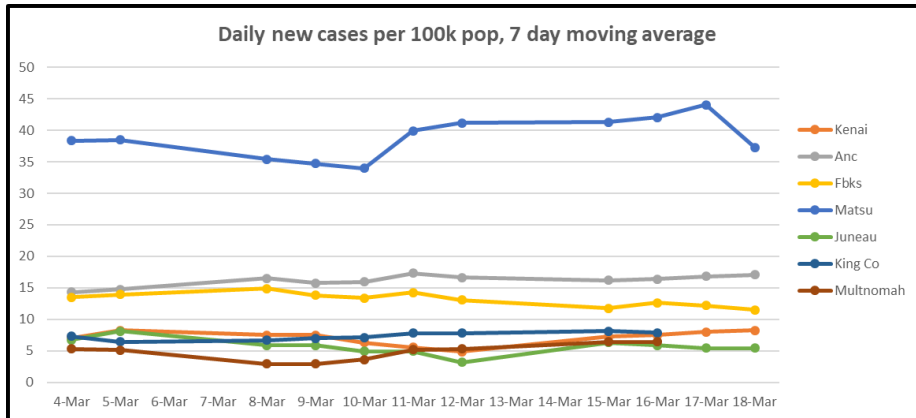


23.0% of the total population of Juneau is fully vaccinated.

46.4% of the Juneau population age 16 and above have received at least 1 dose of vaccine and 28.7% of the age eligible population is fully vaccinated.

The State is reporting that 77.0% of the population in Juneau age 65+ are fully vaccinated.





This chart tracks the number of new cases in the past 7 days, controlled for population. King County (Seattle) and Multnomah County (Portland) are included for context and due to travel frequency. The source data for Alaska is from the SOA dashboard. Out of state data is from the Harvard Global Health Institute (<https://globalepidemics.org/key-metrics-for-covid-suppression/>) and generally lags a day behind most of our other reporting.
