**Situation Assessment:** Our 14 day and 7 day case rate indicators are at the low alert level. The community continues to see COVID transmit via community spread, secondary infection, and travel. COVID vaccine distribution is on the rise which should begin to offer the community some level of protection. The more aggressive variants of COVID-19 have been identified in Alaska. We continue to caution the public to strictly adhere to all travel related rules and to continue strict adherence to masking and social distancing when outside your immediate home.

**Issues of Note:**

Beginning this week, the EOC report will be published three times a week: Monday, Wednesday and Friday. If Monday is a holiday, the report will be published on Tuesday. The CBJ dashboard will be updated on a daily basis during Monday – Friday with the exception of State holiday. In general, the following information will be included: Monday – will include 14 day recap from the Division of Public Health. Wednesday – will include information from the full unified command meetings (BRH, JSD, etc.), and Friday – will include any travel related information.

We had a full unified command meeting today:

BRH: No COVID related cases in house. The Triage building is being modified to more effectively accommodate a stretcher. BRH is working on refining their pre-procedural test process. BRH now has enough N95 masks that they no longer have to reuse masks. The visitor policy has been adapted to allow for up to 2 visitors per patient. BRH is in the final phases with the mining companies to process tests locally.

JSD: Spring break was last week, and the whole district is engaged in distance learning this week. Next week there will be a student vaccine clinic at the high schools. Effective 4/12, HS and MS will switch to In person learning 4 days a week for regular hours. Elementary school will shift to 4, ½ days per week. With CDC changes for schools from 6ft of distance to 3ft of distance, the district is in the planning stages of moving

elementary to 4 full days. Wednesdays will still be independent learning. Staff COVID screening is shifting to the BRH lab. COVID screening will also be available for student activities.

POD Information:

POD 6A: is scheduled for April 5-8, 10am to 2pm. Registration for this clinic opened is open. 1630 doses were allocated for the clinic. Approximately 675 slots remain open – enrolment is slow but steady. POD 6B (Second dose clinic) is scheduled for April 26 – 29.

POD 7A: Will be held on April 9. This is a closed POD for age eligible High School students. POD 7A (Second dose clinic) will be held on April 30. Registration for these clinics will be conducted through the School District. Details will be forthcoming next week through the School District.

Planning for future PODs – is underway this week. There may be one more large weekend POD and then a series of smaller, more targeted vaccination events. More details to follow.

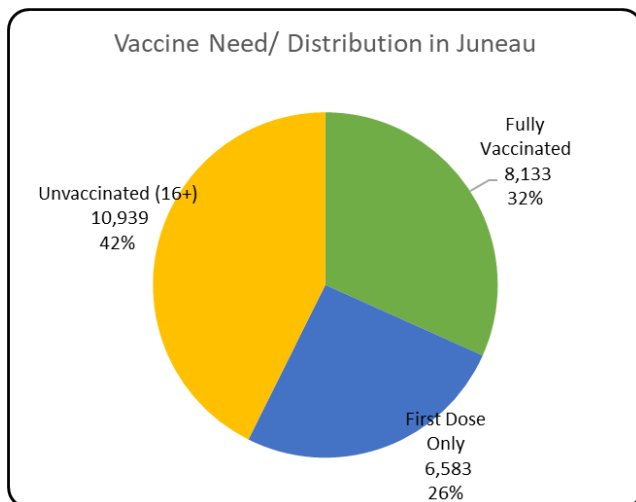

The State did not update their case information today.

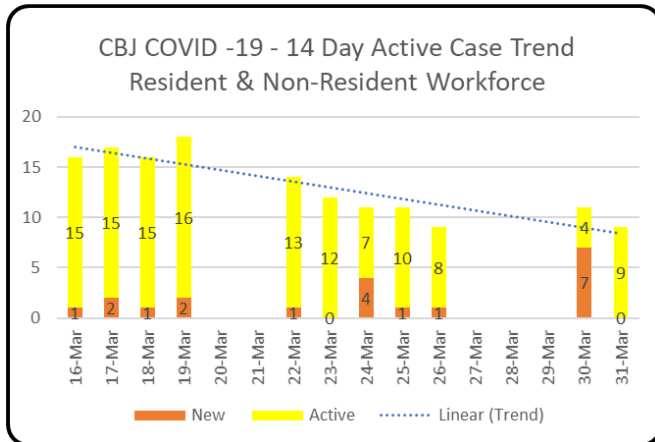
Testing: 45 tests were processed at BRH over the long weekend, all of which returned within 24 hours.



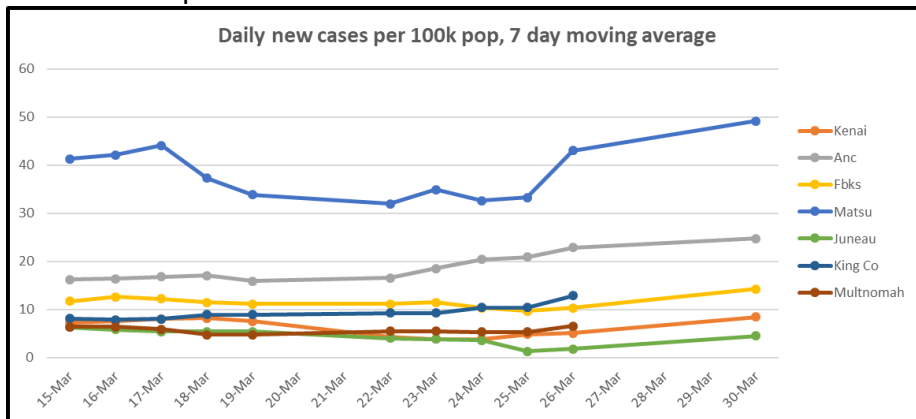
46.0% of the of the total population of Juneau has received at least 1 dose of vaccine and 25.4% are fully vaccinated.

57.4% of the Juneau population age 16 and above have received at least 1 dose of vaccine and 31.7% of the age eligible population is fully vaccinated.

The State is reporting that 78.7% of the population in Juneau age 65+ is fully vaccinated.
