Situation Assessment: Our 14 day case rate indicator is at the low alert level and our 7 day case rate indicator is at the moderate alert level. The community continues to see COVID transmit via community spread, secondary infection, and travel. COVID vaccine distribution is on the rise which should begin to offer the community some level of protection. The more aggressive variants of COVID-19 have been identified in Alaska. We continue to caution the public to strictly adhere to all travel related rules and to continue strict adherence to masking and social distancing when outside your immediate home.

Issues of Note:

Cases are increasing statewide. Residents are cautioned to test upon return to the community even from intrastate travel.

The CDC offered new guidance today on traveling after an individual is fully vaccinated. The EOC is reviewing the guidance and will incorporate any suggested changes into the risk mitigation strategy discussion at the April 12, 2020 Committee of the Whole meeting.

The Juneau Emergency Medical Association is sponsoring monetary prizes for the upcoming PODs at Centennial Hall. Participation in the drawing is voluntary. There will be two cash awards given on each day, one for \$500 and one for \$250. JEMA is also sponsoring a monetary incentive of the same size for everyone who participates in the upcoming vaccine clinics at Fred Meyers.

POD Information:

A new POD (8) has been scheduled for Saturday, April 17th from 10:00 am to 3:00 pm at Centennial Hall. Anyone age 16 and up is eligible to participate. The second dose clinic (8b) will be held on May 8th. Registration is currently open, there are currently 560 appointments available.

POD 4b began today. Second doses will be administered through Saturday.

POD 5b is scheduled from Monday, April 5 through Saturday, April 10. This is a second dose clinic.

POD 6A: is scheduled for April 5-8, 10am to 2pm. Registration for this clinic opened is open. 1630 doses were allocated for the clinic. Approximately 600 slots remain open – enrolment is slow but steady. POD 6B (Second dose clinic) is scheduled for April 26 - 29.

POD 7A: Will be held on April 9. This is a closed POD for age eligible High School students. POD 7A (Second dose clinic) will be held on April 30. Registration for these clinics will conducted through the School District. Details will be forthcoming next week through the School District.

Planning for smaller, more targeted PODs is underway.



<u>Disease Transmission/Contact Tracing:</u>

We are reporting 3 new resident cases and 2 new nonresident cases. 1 case is travel related and the resident is not in Juneau. 1 case is secondary transmission and 2 other cases are under investigation. The final case is an older nonresident case from the seafood industry that was not previously reported.

That State is reporting 205 new cases today brining the statewide total to 63,501 cases.


<u>Testing</u>: 67 tests were processed at BRH since the last report, all of which returned within 24 hours.




46.3% of the of the total population of Juneau has received at least 1 dose of vaccine and 26.2% are fully vaccinated.

57.8% of the Juneau population age 16 and above have received at least 1 dose of vaccine and 32.6% of the age eligible population is fully vaccinated.

The State is reporting that 79.42% of the population in Juneau age 65+ is fully vaccinated.





This chart tracks the number of new cases in the past 7 days, controlled for population. King County (Seattle) and Multnomah County (Portland) are included for context and due to travel frequency. The source data for Alaska is from the SOA dashboard. Out of state data is from the Harvard Global Health Institute (https://globalepidemics.org/keymetrics-for-covid-suppression/) and generally lags a day behind most of our
