Situation Assessment: Our 14 day case rate is at the moderate alert level and our 7 day case rate is at the high alert level. The community continues to see COVID spread in the community with a higher proportion of cases occurring in youth under the age of 19. Two variants of concern have been identified in Juneau - (UK/B1.1.7 and Brazil/P1). Case rates statewide are declining.

Issues of Note:

Today we passed the benchmark of 50% of the total population fully vaccinated. Fully vaccinated is defined as shot series complete plus 2 weeks. The community risk level is now at 1b.

Youth ages 12 and up have been cleared for the Pfizer vaccine. There are 1600 youth in Juneau between the ages of 12-15. Clinics are scheduled on May 14 at the high schools and May 17 at the middle schools.

Clinics will be open to any youth 12 and up and any of their family members who wish to be vaccinated regardless of school enrollment status.

Capstone will begin providing vaccines at the Juneau International Airport on Saturday, May 15th.

We have a new cluster that is the result of a small private party. That cluster is currently at 7 confirmed positive cases.

There are a number of clinics planned for May throughout the community. Many of these clinics were originally set up as 2nd dose clinics which will now also be offering the Janssen vaccine. Clinics are being held on the following dates. Registration for the clinics is on line or be calling the hotline at 586-6000. Walk in slots are generally available.

New shot clinics (Pfizer and pending availability, Janssen (J&J):

Sign up for an appointment at <u>juneau.org/vaccine</u> or call 586-6000. Registration isn't required – the May 22 clinic will be open to drive-ups and the May 26 clinic will be open to walk-ins; choice of vaccine will be dependent on availability.



Disease Transmission/Contact Tracing:

We are reporting 5 new resident cases and no new nonresident cases. 3 cases are secondary transmission, 1 case is travel, and the remaining case is under investigation. We have two private gathering clusters that are active. The older one is at 7 positive cases with 6 recovered. The newer cluster also has 7 positive cases with none yet recovered. 1 of the new cases is associated with the school district. JSD has contacted anyone who may have been impacted.

That State is reporting 84 new cases today bringing the statewide total to 69,267 cases. This is a total of 150 new cases since the last EOC report.


Testing: 159 COVID tests were processed at BRH since the last EOC report, all tests returned in less than 24 hours.




Total: **59.2%** of the of the total population of Juneau has received at least 1 dose of vaccine and **55.3%** have completed their vaccine series.

16+: **73.3**% of the age eligible Juneau population has received at least 1 dose of vaccine. **68.5**% have completed their vaccine series.

65+: **94.5**% of this age group has at least one dose of vaccine. **91.2**% have completed the vaccine series.
