Situation Assessment: Our 14 day and our 7 day case rates has dropped to the minimal alert level. The community continues to see COVID spread in the community with a higher proportion of cases occurring in youth under the age of 19. Two variants of concern have been identified in Juneau - (UK/B1.1.7 and Brazil/P1). Case rates statewide are declining.

Weekly Summary – 14 day lookback for positive tests collected May 10th –May 23rd.

Over the last rolling 14 day period, 17 people tested positive for COVID-19 in the community.

Highlights:

18% of the cases were associated with a cluster that was a result of a private gathering. There are 9 identified cases with that cluster – 8 have recovered.

12% of the cases were designated as community spread, 59% of the cases were designated as Secondary Infection, 17% of the cases were associated with Travel, and the remaining 12% of the cases remain under investigation.

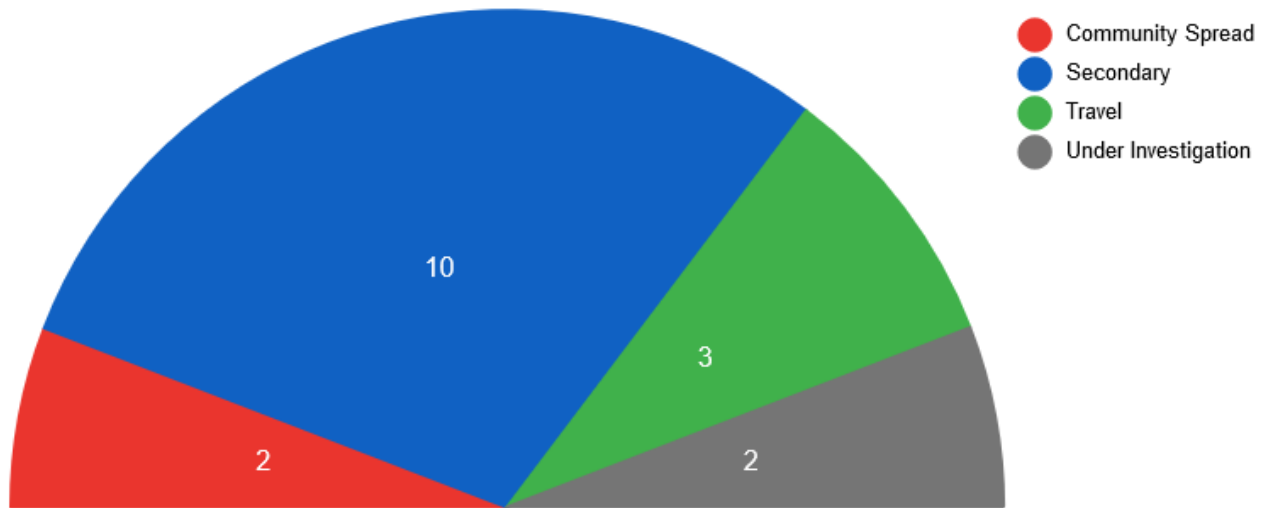
Contact tracing is at 100% of individuals being contacted within 24 hours of a positive test being returned.

Disease spread is proportionally higher among individuals under the age of 19 and less prevalent in those over the age of 60. There is case positivity among most racial groupings, and more cases in females than males (65%/35%).

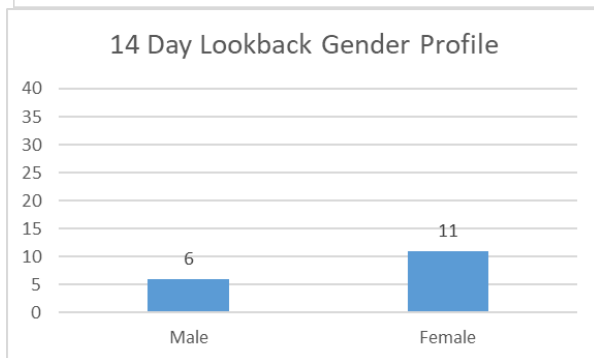
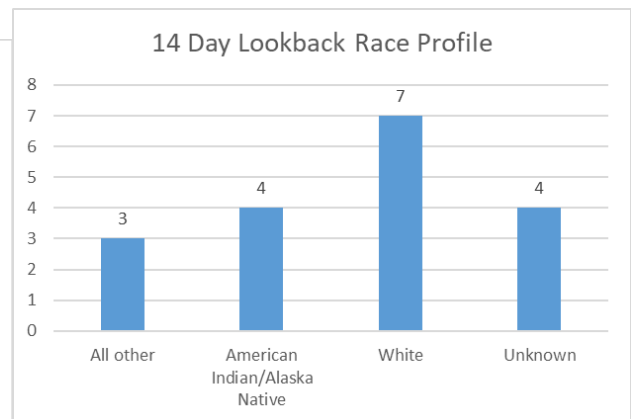
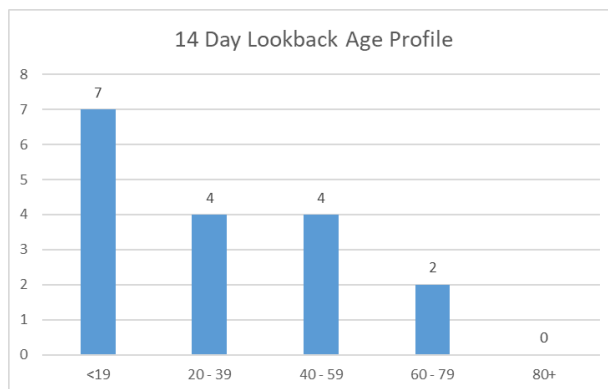
Disease Acquisition:

Of the 17 positive cases during the last 14 day period, 2 were identified as community spread, 10 were identified as secondary transmission, 3 were identified as travel related, and 2 remain under investigation.

Issues of Note:

Administrative processes for weekly asymptomatic screening is on target to be completed this week. Bars, restaurants, day care, summer camp, and small retail businesses have been prioritized for no cost COVID screening for employees on their staff who have not been vaccinated. CBJ staff that regularly interact with youth are part of this pool. Testing is expected to begin June 1st.

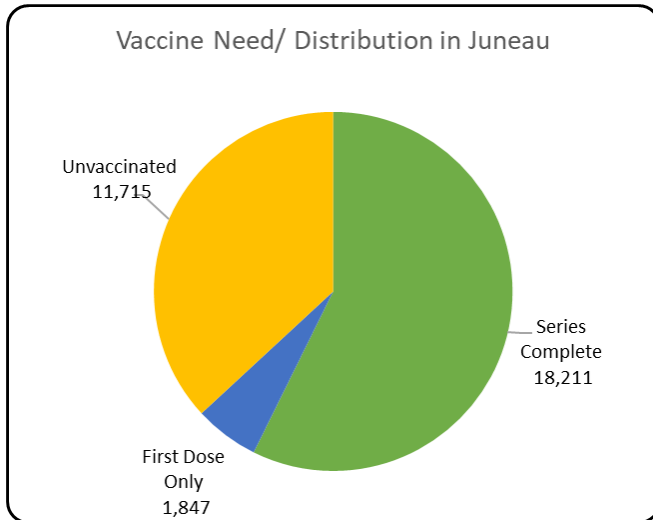

Disease Transmission/Contact Tracing:

We are reporting 2 new resident cases and no new nonresident cases. 1 case is secondary infection and the other case is under investigation. The private party cluster has 9 positive cases with 8 people recovered.

That State is reporting 21 new cases today bringing the statewide total to 69,999 cases. This is a total of 97 new cases since the last EOC report.

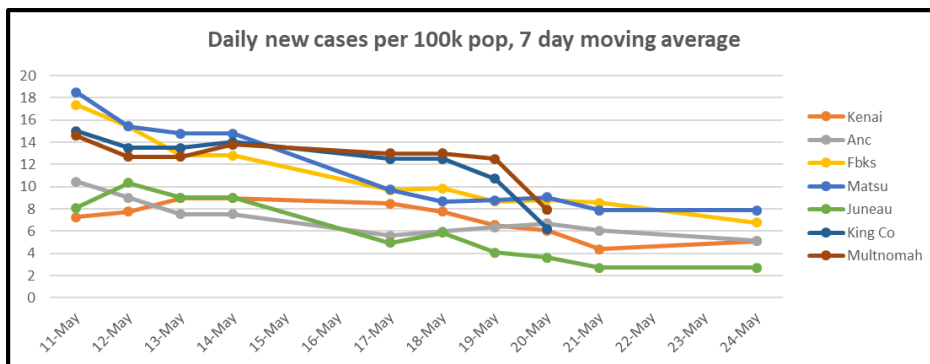
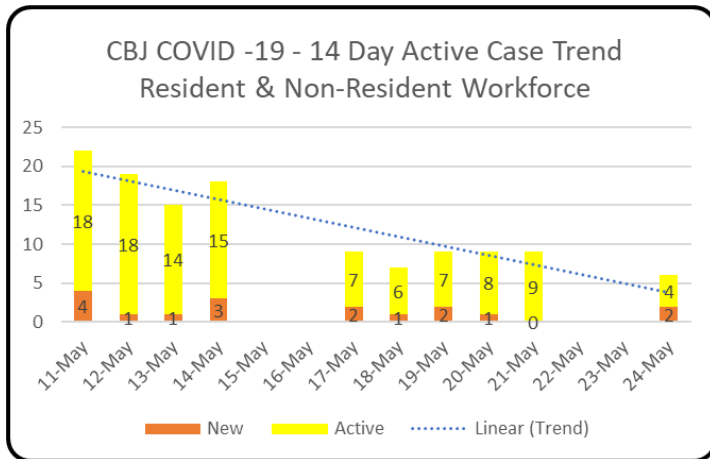
Testing: 131 COVID tests were processed at BRH since the last EOC report, all tests returned in less than 24 hours. 182 tests were collected by the CBJ teams last week.



Total: **63.1%** of the of the total population of Juneau has received at least 1 dose of vaccine and **57.3%** have completed their vaccine series.

12+: **73.6%** of the age eligible Juneau population has received at least 1 dose of vaccine. **66.8%** have completed their vaccine series.

65+: **94.8%** of this age group has at least one dose of vaccine. **91.8%** have completed the vaccine series.



This chart tracks the number of new cases in the past 7 days, controlled for population. King County (Seattle) and Multnomah County (Portland) are included for context and due to travel frequency. The source data for Alaska is from the SOA dashboard. Out of state data is from the Harvard Global Health Institute (<https://globalepidemics.org/key-metrics-for-covid-suppression/>) and generally lags a day behind most of our other reporting.
