Downtown Waterfront Improvement Project:

This \$12M project provides the local community and visitors additional open space and loading facilities for shore excursions. Over 1 acre of timber decking and staging was constructed, supported by more than one hundred steel piles. It includes infrastructure for future electric bus charging stations and the utilities for future restrooms and covered waiting shelter. Funding was provided by Marine Passenger Fees, Commercial Passenger Vessel Excise Tax, and CBJ Dock Enterprise Fund Balance.

Mike Pusich Douglas Harbor Zinc Anodes:

This \$254K infrastructure project, completed in July 2020, extends the useful life of the galvanized steel piles at Douglas Harbor. Funding was provided through a 50% matching grant from the Alaska DOT and CBJ Harbors Enterprise Fund Balance.

Harris & Aurora Harbor Maintenance Dredging:

The US Army Corps of Engineers provided the design and construction funds to dredge both Harris and Aurora Harbors back to the original basin depth and perform maintenance work on both breakwater structures. This work has extended the facility life and provided needed navigational improvements for harbor users.

LUMBERMAN Disposal:

Docks & Harbors in cooperation with our federal partners (US Coast Guard, EPA, NOAA) and Global Diving & Salvage, completed the environmental remediation and permitting of the derelict vessel LUMBERMAN. On May 2nd, LUMBERMAN was committed to the deep in the Gulf of Alaska - 50 miles offshore in 8000 feet of water.
