How to eFile a CBJ Sales Tax return

Step 1 – Log in to your profile

- Enter your User Name and Password and select “**Log In**”

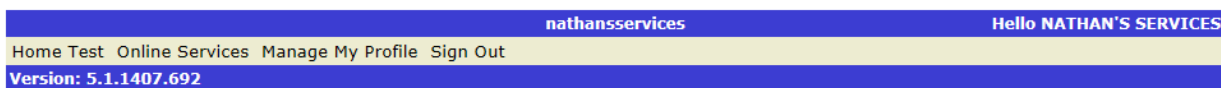
