## V. Public Hearings

1. Public Hearing - Dockage Charges (05 CBJAC 15.030)

Mr. Uchytil said on page three of the packet is the regulation change approved by the Assembly. The notable changes are that vessels from 65 to 200 feet the dockage fee changes from \$2.50 to \$5.00. Vessels less than 200 feet changes from \$1.50 to \$3.00 per foot. What didn't change was vessels over 200 feet remain the same at \$3.00 per foot. The Assembly recommended to not adjust the fees for the over 200' for cruise ships that pay marine passenger fee. We do have cruise ships under 200 feet paying marine passenger fees and if this is passed tonight they would be exempt this year from the increase and still pay the \$2.50 per foot rate. This has been discussed at previous meetings.

#### **Board Ouestions**

Mr. Ridgway asked if the Assembly sent the Board something in writing the request to exempt the smaller cruise ships from the rate increase?

Mr. Uchytil said no, but staff believes the desires of the Assembly was to exempt cruise ships paying passenger fees to not pay the increase in fees.

Mr. Etheridge said that was his understanding as well. After the rate study is completed is when there would be the potential to raise the cruise ship rates for vessels over 200 feet.
