Thank you for contacting the TBMP hotline. Alaska Department of Environmental Conservation (ADEC) oversees permitting for cruise ships regarding wastewater discharge permits, testing and sampling for the State of Alaska.

NorthStar Trekking: Can't tell exactly from the comment if the caller was referring to the day he called in or just in general, but if it was regarding the 10th of May NorthStar did not have any aircraft flying that day due to weather. NorthStar does utilize the Auke Bay approach and departure route but only when the weather is sufficient for our aircraft to be at or above 2000'. There are only two routes out of the airport going west and NorthStar will utilize both but we will always be at or above 2000' when crossing the ferry terminal in route to the Mendenhall Glacier or returning to the airport.

Coastal Helicopters: The Auke bay departure and arrival route has been developed over the years to mitigate noise in the Mendenhall valley, Fritz cove, Auke bay and around the airport. This route is used by Coastal Helicopters as a route to safely transit between the Juneau airport and the Herbert glacier. During the fall of 2018 and spring of 2019 the Juneau Air Traffic Control tower personnel worked diligently to change the way the helicopters moved around Juneau, in fact they were insistent that the Auke bay route get angled North from Pedersen hill causing the sound signature of the helicopters to resonate into the Auke bay basin. The Heintzelman Ridge departure and arrival route is a very narrow and congested corridor, it is used primarily by one company on days when the weather allows. When plausible we use the Heintzelman for access to some areas and we also use routes East that turn North up Lemon Creek and other routes that continue over town. We will make sure that when the weather allows our pilots will be at least 2,000 feet over Auke bay. I don't know where you live but the Auke bay route used to continue West from Pedersen Hill to Auke Cape before turning north. Please give us some information about your location. Every year we meet and discuss ways to alter our routes to mitigate impact on those near our flight paths.

TEMSCO: TEMSCO uses the Heintzelman Ridge route, almost exclusively, into and out of the airport's controlled airspace for our glacier tours when weather permits. The Auke Bay route is frequently used for non-tour related flights such as medivacs, government, and private charter work to name a few. If you see anything out of the ordinary, sharing specific information such as time of day, number of, and color of aircraft can help us address concerns.

Kirby Day: Thank you - I have been in touch with the caller. The caller is correct. I am checking with CLIA-Alaska (Cruise Line International Association-Alaska). We discussed this on the Task Force and my understanding is that this issue is part of a Memorandum of Understanding (MOU) between CLIA-Alaska members and the City and Borough of Juneau that is being finalized and readied for signature in port. CLIA has sent out a message to - with a number of other items on it.

That said, I will do my best to see if we can push this item on the MOU list nearer to the top and start asking ships to agree to comply ahead of the entire MOU being signed.

Kirby Day has spoken to the caller and will discuss with Travel Juneau to ensure that volunteers are sharing that the city bus will stop 1-1/2 miles from glacier and visitors must walk the rest of the way. Also sharing that there are no restrooms until they arrive at the glacier. There are also some traffic and pedestrian issues which will take some time to address but should be rectified. Kirby will work with the CBJ Tourism Manager on this and the other issues discussed. In 2020 a new letter of agreement with Juneau's Control Tower was signed and at the request of Air Traffic Control (and against the operators wishes) a very minor change to the routing on the Auke Bay Arrival and Departure occurred. Long story short aircraft now are slightly more to the east when crossing the ferry terminal, especially when there is opposing traffic. The change in essence moved the southern most lane of traffic 1000' to the north when crossing Auke Bay and this has the effect of moving traffic slightly to the east when crossing the ferry terminal (easier explained with graphics). Anyhow, all other elements of the route remain the same and in NorthStar's case our aircraft should always be at or above 2000' AGL when on this route. I can't tell where this particular caller lives by their message but if they live East of the Ferry terminal I suppose that it is possible that their perception of more noise could be valid however I also have to believe that 2 years of very limited use might be playing a role as well.

5-16-22 -- Princess Cruises, Holland America Line and Seabourn Cruise Line have all agreed to shut off their large outdoor video screens completely while in port in Juneau. Ships have been running these silently for years with only visuals and no sound. We have agreed now to let them go dark while other member cruise lines to ask that they comply with this request as well.

Chimney Folly

There has never been any doubt that I married a remarkable talented man. Most people, especially in his later years, remember Sandy \_as a competent caring man who read everything and could talk intelligently on any subject. What people, with the exception of his close friends and family might not know is that there could be a sense of daring and maybe even recklessness at times. Oh, not for fun or pleasure, but certainly if the task at hand required it. That combined with the most dogged persistence known to humankind helped him accomplish seemingly impossible tasks required from equally seemingly impossible goals.

The case in point is his decision to build our house in Connecticut. He, who had never even taken a shop class in high school, decided he would build our house himself after we had bought the land and the builder backed out. With books in hand he proceeded to undertake the complex task of building a very complicated house. (Nothing he ever did was uncomplicated.) With the help of friends, wife, and family,on weekends and nights after working a corporate job in New York City all day every day, he set out to do the near impossible. If it was in a book it was doable as far as he was concerned.

As a followup to yesterday's letter about the helicopter noise at my house I offer this little vignette.

s my mother climbing on the car to watch and I must have been the videographer on the roof. You certainly couldn't get me on a roof 20 feet off the ground now but it was a daily occurrence then.

I was sitting in the sun on my deck today reading and enjoying the ruby crowned kinglets wonderful song. They do seem to be everywhere right now. It was apparently a low ship day; fairly quiet skies and water traffic. I heard the helicopters long before I saw them. At the same time I saw an Alaska Airlines jet approaching in the distance. The helicopters continued their noisy approach before I could hear the plane.

As the helicopters flew just to the right of my house the plane flew just to the left. The interesting thing is that I could not hear the jet plane above the noise of the helicopters. I saw all three aircraft but could hear only the two helicopters. They were likely about the same distance and altitude from me as the jet.

If two helicopters can drown out the sound of a jet, think what happens when they fly over in strings of seven or more. You guessed it. My house on a high ship day is very like living on the runway of the Seattle airport would be. The noise is truly beyond deafening and it never stops. As one group is going out another is on its way back. It takes several minutes for five to seven helicopters to pass overhead. Jets are loud too, but they fly over quickly and the noise is just for a few seconds.

I don't usually think of myself as a complainer, so I don't make these posts lightly. It just struck me as I observed this today that I am not just complaining about nothing. If a helicopter is louder than a jet and the sound lasts several minutes longer; just try to visualize six or more jets flying just overhead one after the other for hours on end.

Coastal: Sorry you had such a negative experience yesterday. We have not changed any of our routes and are currently flying the routes that have been laid out in our agreement with the Juneau Tower. We will continue to monitor our pilots and make sure that they are following those routes. Please don't hesitate to provide any feedback if you see anything different.

TEMSCO: Temsco Helicopters continues to comply with the established flight routes designed to mitigate helicopter noise in Juneau. Temsco has worked with the community, Juneau Air Traffic Control Tower and the FAA to establish routes to and from the airport with the least impact to residents. When weather allows, Temsco departs and arrives at the airport via the Heitzleman Ridge route which is not close to Berners Ave. Today we had six departures and arrivals that utilized the Mendenhall departure route and the Auke Bay arrival route. This was due to clouds on the ridge not allowing the Heitzleman Ridge route to be utilized. After 1036 AM the clouds lifted and all of Temsco's helicopters were departing and arriving via Heitzleman ridge the remainder of the day. I do not know the specific location of the homeowner on Berners Ave, but the center of that street is less than (0.2) two-tenths of a mile from the departure leg of routes going west of the airport. Berners Ave is located only (0.4) four-tenths of a mile from the extended centerline of the main runway of the airport. Helicopters do not use the runway and are restricted to operating on the north side of the runway for departures and arrivals. All of the helicopter companies fly a very compressed traffic pattern for the sole purpose of noise mitigation to the North of the Airport. Inbound and outbound helicopters fly within . 15 miles of each other in opposite directions. Most airport traffic patterns allow for at least one half mile of separation from the upwind and the downwind legs of the traffic pattern. For example on the south side of the runway airplanes routinely fly their downwind leg (the leg that would be furthest from the runway) three quarters to one full mile away from the runway. I would encourage anyone who may suspect there are deviations being made to these established routes to note the time, location and color of the helicopter if possible so that operators may investigate any pilots flying off route and make necessary adjustments through continued training.

Northstar: The area that the caller lives in is very near to the airport and very near to NorthStar's base location on the airport. Although she did not mention blue helicopters, which comprise the majority of our fleet I have no doubt that NorthStar will be seen by her and others in that neighborhood. The "route" in discussion is actually the airport traffic pattern and is actually designed (at operators insistence) in a nonstandard way in order to do as much as we can to avoid overflight of this neighborhood. It's recently come to my attention that once again the controllers in the tower have organized and are again trying to change this non standard section of the pattern (as well as a few other routes) which will directly route helicopter traffic over this neighborhood. The operators will oppose this. Currently we have the final portion of the downwind leg of the pattern "canted " inward near the waste water treatment plant to allow helicopters to remain over airport property when transitioning this area. A standard pattern would have this corner squared off and that would put the traffic directly over La Perouse and Berners avenues. In addition to this NorthStar will request "opposite flow" when we safely can in order to remain in the southern most lane of traffic when approaching or departing our ramp because we know that due to our position on the airport we have the potential to impact this neighborhood the most.
