CLARIFICATIONS:

QUESTION: "What size Temporary Fuel Tank is needed?"

RESPONSE: 5000 gallons is specified to ensure boilers have an ample fuel source between regularly

scheduled fuel deliveries. Boilers use approximately 800 gallons per day.

QUESTION: "Who arranges and pays for the Fuel filling of the Temporary Tank and refilling and

management while in use?"

RESPONSE: It is the contractor's responsibility to manage any temporary system put into place. This

includes arranging for refilling, payment for fuel, and ensuring the system is code

compliant.

QUESTION: "Is there any way we could install a temporary Fuel submersible pump and source the

fuel from the existing BG Fuel tank, instead of installing a temporary Tank? We would propose to run fuel hoses from the existing tank then into the building mech room for tie-

in. Please check with design team for viability and design of this approach?"

RESPONSE: Alternate Fuel Supply plans may be submitted for approval to the engineer after

award; See Project Manual Item No. 1 of this Addendum.

QUESTION: "Another Idea might be to move the existing Day Tank to a location outside of Building

and connect with hoses. This appears to be a capacity of 500 gallons, would this suffice

for a temporary Boiler supply?"

RESPONSE: The existing day tank can be utilized in an alternate Fuel Supply plan, but is not

sufficiently sized per Contract Documents.

QUESTION: "Being that this work is limited to the building exterior and Boiler room, would ICRA

requirements actually be needed for this project? Is there a requirement that workers be

COVID vaccinated?"

RESPONSE: ICRA documents are required, but it is very probable that once the documents are

filed, a permit will not be required. COVID vaccination is not required.

QUESTION: "Please consider deleting the requirement that General Contractor have an on-site

representative at all times that any work of any trade is going on, which would provide

large savings."

RESPONSE: A representative of the General Contractor will need to remain on site at all times

during any work.

QUESTION: "Are there any Seismic requirements?"

RESPONSE: No.

QUESTION: "120 day bid hold-open causes additional escalation expense. Can this be reduced to

60 days?"

RESPONSE: Yes, see Project Manual Item No. 2 of this Addendum.

PROJECT MANUAL:

Item No. 1 SECTION 00030 – NOTICE INVITING BIDS. DESCRIPTION OF WORK

Add the following paragraphs to the end of the Description of Work:

"It is the CONTRACTOR'S responsibility to ensure the boilers and backup generators fuel supply is not interrupted. The intent of the temporary fuel-oil supply is to ensure the existing hospital heating and backup generation remain fully operation during construction, with boiler shutdowns limited to one hour. The temporary fuel connections and temporary fuel tank specified in the Contract Documents is the basis of design to keep the heating and backup generating systems fully operational. The CONTRACTOR may elect other means and methods to meet the specified requirements for maintaining the heating and generation fuel supply. Should the CONTRACTOR'S means and methods vary from the basis of design, the CONTRACTOR shall submit the alternate Fuel Supply plan to the ENGINEER for approval prior to implementation and interruption. The CONTRACTOR shall be responsible to provide all components necessary for implementing the alternate Fuel Supply plan if approved."

Item No. 2 SECTION 00030 – BIDS TO REMAIN OPEN **Delete** 120 Days and **replace with** 60 Days.
