The Alaska luxury tour white van pulled up and parked right in the crosswalk. I said to the guy welcoming people and loading them and "hey you're parked right in the crosswalk it's probably not the Best place to park" His reply; "well I wasn't driving and I didn't park here." Which I took is a very flippant answer. It's his company too. It's just arrogant that a tour group feels they have the right to park on top of the crosswalk when there are 100 and some passengers getting off of a plane. I've tried to call them several times to talk to them about it but they never answer the phone so finally today I'm sending you a complaint. I'd like to hear their response back.	Alaska Luxury Tours	Thank you very much for bringing this to my attention. I looked back at our booking calendar and saw that we had no airport transfers scheduled on the evening of June 22nd. I then remembered letting a friend borrow one of our vehicles to pick up his friend that night on the flight you mentioned. I'm guessing that you can recall the gentleman was not in an Alaska Luxury Tours uniform. I'm very sorry for the flippant remark, the person driving the van was not an employee of Alaska Luxury Tours but unfortunately labeled as such since our company name is plastered on the side of our vehicles. This does not excuse his comment. This is a good reminder that regardless of who was driving our vehicle that night, their actions reflect on the image of our company. I can assure you that our company policy for airport pickups does not include parking in crosswalks, as we have a permit to pick up in a very specific location. Moving forward, I'll use better judgement on who can use our vehicles and once again, my apologies for this and thank you for letting me know about it.

If they are now using school buses I am even more upset. This just cannot continue. Ive had people from the Juneau Police department reporting on numbers of vehicles and its astronomical already. Im hoping to get some further information from them. But a full size school bus on that road is outrageous. So please I hope that you will check into it and let me know whats going on. Thank you. 7/1/2022	69-7/1	Vehicle: Bus/Trolley	Basin Road	Hi, Im on Basin Road and the bus stopped at the Mount Roberts Trailhead and I checked with them. It's a church group from California that's rented the bus for the week. I assume they're just going to hike the trail and won't be back. But I just wanted you to know that Im still really upset about all the traffic up here and will continue to monitor it. Im going to try to get them to put the counter in again during the heavier months. They had it up here in Juneu earlier. I think the heaviest day was 455 vehicles which I think is outrageous. I will be submitting a report to the assembly at some point. Thank you.	Kirby Day	Hi ---, thanks for calling the TBMP hotline. I understand the frustration with the amount of traffic on Basin Road but am still uncertain how much of it is "organized" tourism and how much is purely independent visitors as well as local traffic. I think ATA stopped running full size school buses up there years ago, so makes sense that it wasn't them and turned out to be a private church group with a rented bus. In regards to you getting reports on vehicle numbers using Basin Road, this is a good idea in order to gauge if any improvements could be made to the current road, realizing that there are likely very few given it's geographical location. I am uncertain how JPD numbers will be able to distinguish between organized tours, independents, rental cars, and local residents. The Mt Roberts Trailhead, Perseverance Trail and Basin, and that area is well advertised on websites, city maps, blogs and in trail books and trail maps. As well, I have been hearing radio ads for Last Chance Mining Museum for the last couple of weeks ("come up Basin Road into Last Chance Basin" ... something to that affect) so individuals who have friends and family visiting and travelers who rent cars and pick up a map or google the area will easily find their way up there. I don't know the answer. Any tour vehicles using this area should be held to the same standards as vehicles driven by local residents as well as rental cars. I think anything that the city could install to "calm" the traffic might be helpful. We made a couple recommendations at the Visitor Industry Task Force but those did not make the cut.	

7/1/2022	70-7/1	Vessel: Whale watching	Coughlan Island	Hello, Im a local and I was trying to navigate through the Coughlan Cut, I believe this was on Tuesday. The was a big Allen Marine cat, the St Yakov, and for some reason they slowed down to about 5-6 knots. There was 5 boats behind them. And I am jammed up in this little spot that was so hostile for me to try to navigate with boats coming and going trying to navigate this small passageway because a big boat plugged it up. I would like to please encourage Allen Marine, if you're going to slow down, please avoid this area. Just go around Coughlan. Slowing down on Tuesday knocked all my crap all over the boats and made it extremely unsafe for my little aluminum boats and it was very hectic to get through. Trying to read everyone elses angles and avoid collisions as everyone else thats going through there is still trying to go fast but we have this big huge boat plugging up the whole works. Thank you, please stop doing that.	Allen Marine	Thank you for the feedback. Since no name or contact information was provided we could take no action to clarify the situation. We will discuss this day to see if the captain remembers anything specific about this timeframe. Please note we received this comment today about the same vessel in the same location approximately a day after this comment was made: "Hello! Just came through Coughlan, on the big boat with my kids chasing on the skiff and so appreciative of the slow speed and wide berth the Yakov gave us. Very respectful!"	
7/5/2022	71-7/5	Vehicle: Bus/Trolley	Downtown Juneau	I'd like to talk to somebody about a conversation I had with a bus driver downtown tonight. If somebody could give me a call back. Thank you, goodbye.	Alaska Coach Tours	Alaska Coach Tours reached out and spoke with the caller and resolved the situation.	
7/6/2022	72-7/6	Vehicle: Bus/Trolley	Downtown Juneau	To: Gray Line of Alaska. This afternoon, Wednesday July 5, at about 3:15 pm, I was walking my bicycle across Egan Drive at a well marked pedestrian crossing at Glacier Ave. This crosswalk has multiple yellow warning signs and bright flashing lights which were flashing at the time. This section of Egan Drive is 2 lanes outbound and 2 lanes inbound. Your small bus was traveling outbound in the left lane. I was in the median. The driver ran through the crosswalk, completely ignoring me and the other cars going in the same direction, which had heeded the signal and had stopped. My impression was that the bus was traveling above the 35 mph speed limit. Your drivers must be better trained in local conditions and safe driving practices. Please note that this crossing has been the site of vehicle/bicycle accidents, one of them very recently.	HAP	Thank you for bringing this situation to our attention. Unsafe driving practices like this are absolutely not okay, and I thank you for this information so that we can address this behavior with the driver. I am sincerely sorry that you were put in this situation. We are following up with this driver to ensure that they abide by the rules of the road and are vigilant in their awareness of pedestrians. Again, deep apologies and thank you.	You are correct. Bus drivers also act as tour guides and are expected to be able to drive and tour in a safe manner. It is a relatively common practice to hire drivers as guides, and one of the TBMP guidelines touches on this issue in regards to the downtown area. 13. TRANSPORTATION OPERATORS employing Driver-guides (those who drive vehicles and provide commentary simultaneously) will incorporate defensive driving and road environmental awareness into their training program curriculum in an effort to reduce any potential safety risks associated with this practice. Driver-guides will be encouraged to refrain from delivering tour commentary while transiting areas of increased congestion such as downtown loading areas and portions of South Franklin Street that may be congested during periods of the day. The training program our drivers complete includes both defensive driving and road awareness. The fact that a driver is not following the necessary training techniques as they go through downtown is concerning. This will be addressed. Thank you for bringing this to our attention so that we can fix it.

The fact that there were not audible announcements outside during the course of the day leads me to believe someone made a mistake. Regardless, I will follow up. Thank you.

7/17/2022	81-7/17	Other	Juneau	I am writing to point out needed repairs to Glacier Hwy regarding Ironman racing bicycles with skinny tires. Perhaps this is already in the works. If not please accept my comments on problem areas. On Glacier Hwy, just before Mile 15, and on to Mile 16. are some narrow strips of pothole running alongside the white stripe on the side of the road. This rut or elongated pothole can be dangerous to skinny bike tires, as such tires can ride into that gap, longitudinally, and cause the rider to loose control of the bike, and possibly crash. Most of the bike tires are narrow, say 23 millimeters wide, and as such, such gaps can cause serious problems for racers. These long narrow potholes are near the white line and the concern is that in the Ironman race riders will pass other riders and thus ride at or near the white line and right into the dangerous cracks. Can these be fixed? I see where some of these areas have been fixed in the past (This crack seems to be associated with a construction seam that has failed). Thank you for your attention to this.
