Good evening. Lam emailing you directly, because the general TESMCO, Northstar, email requests a specific time and date to submit a complaint. I am Coastal Helicopters completely frustrated by the helicopter noise. I have lived by the airport on Radcliffe Road for five years. When I moved here, I understood that living by the airport would come with airplane noise--jets and bush planes taking off and landing. What I was not prepared for was the amount of helicopters flying over my house all day, every day during the summer. They begin around nine in the morning and go until nine at night. They leave in groups of two or three, and right after they take off and pass, another group comes by to land. When I am outside on the deck with guests or family members, conversation has to stop. If it is a warm day, the windows are open and we hear the helicopters throughout the house (over the ty). On big cruise ship days, I would say we maybe have ten minutes of quiet before more helicopters come and go. I am not opposed to tourism. I am opposed to my quality of living being compromised because of noise. We live in Juneau for a reason, and I am starting to feel like residents are sacrificing their quality of life. Is there any chance for looking at alternate locations for helicopter operations? Perhaps just one company flying out of the airport would be more appropriate? I would even invite you to come to my house and hang out so you can see what a nuisance this noise is, particularly when you are trying to relax at your own home! Thank you for listening.

Hello, my husband and I are calling because this is the second time Alaska Coach Tours in a matter of a few days that we've observed Alaska Coach Tours bus #220 out on Egan Drive. It needs servicing. The emissions, the amount of diesel coming out, black smoke, that bus needs to be fixed. Like I said, second time we've seen it in the past couple of days. Very noticeable compared to other vehicles and other buses. If you could let Alaska Coach Tours know, again bus #220 needs to be worked on. The emissions are polluting. Thank you Hi, I live in Auke Bay, right at the harbor. Im calling to complain TEMSCO, Northstar, about helicopter noise in Auke Bay. I think that 8:45 pm is way too Coastal Helicopters late in the day to be hearing helicopters inside of your house. I think that we need to talk about hours of operation. If they want to operate 8-5, 9-5, or 9-6 or something like that, that's one thing. 8: 45 on the regular all summer long is not gonna work. I dont care what route they fly, it's not going to work. They need a different departure and arrival location that does not include the residential area of Juneau. So, I know that everyone's going to talk about routes and mitigation and what happened this day and the other. They need to fly in and out of some other location. They're going to the ice fields, that's on federal property. Let them find a heliport, helipad, launch spot, whatever on federal land that does not fly over residential land. Nobody comes to Juneau to fly over Medenhall Valley and look at people's yards. The same is true for Auke Bay and downtown Juneau. I do not want them flying over my house at 8:45 for the rest of the summer. I dont care who it is or what route it is, they need to respect business hours.

There are also aircraft identifiers and routing on the TBMP website on the links page (www.tbmp.info). Most all of the routes into and out of the airport are dictated by the FAA Tower at the airport and all aircraft must follow those regulated flight patterns. As well, some 20 years ago there were numerous meetings and collaboration efforts between flightseeing companies and the community, and a flightseeing noise committee overseen by the US Forest Service in an attempt to manage routes and times of operations to reduce the impacts of flightseeing noise. The results of a couple of years of meetings is where we are now and fostered the restrictions and route changes that are now part of TBMP and flightseeing aircraft operations. During these meetings which stretched out over years, although discussed, there was no alternative location for helicopter bases found that were reasonable and safe. Simply creating a new departure point (away from the airport) for helicopters - regardless of whether they were flying tourism or nontourism flights was found not to be a viable option and would create another area where helicopter impacts might become an issue. It was more logical to work with routes and times of operation (as we did) and keep these aircraft operations at and around the airport. TESMCO: This was not our tour. All operations were completed by 1916 (7:16PM) by Temsco on 6/14/2022.

Coastal: Our tour flights were delayed that day due to outside scheduling problems. Often we have industrial flights (mining support, communication networks support and construction support) that return later in the evening. Our flight routes are designed and dictated by the Juneau AirTraffic Control Tower, in the past our flight routes over Auke bay were directed further south and avoided more of the Auke bay. Bay Morth and created a different noise signature in Auke bay. Each year we discuss ways to change the routes to mitigate impacts to residents. During these and other meetings there is always talk of finding alternate areas to operate from. Currently there is no other area except the Juneau Airport.

All guests are required to sign a contract agreeing to abide by local laws that include many aspects of safe vehicle operation, but it is not a problem to remind them.
48-6/20	6/20/2022 Vehicle	Glacier	I am calling with a complaint about a speeding bus driver at the glacier. This incident occurred around 2:45ym on Friday. June 18th. I was standing alongside Glacier Spur Road, north of Steep Creek culverts in a speed zone that is 20. Two deer had just been near the road, a bear had just crossed the road and two dark green buses, which I believe is ACT, speed past me going faster, I believe, than the 20 mph speed limit. The reason I say this is because I am a retired Ranger from the glacier and spent a number of years there trying to assist drivers in meeting the standard of 20 mph. Currently the speed hump has not yet been installed. Im working very hard to get them installed because they're really important. This particular incident really bothered me because I gestured strongly to the second dark green bus to slow down because the animals were nearby and the second driver stuck her hand out and pointed to the 30 mph zone sign that was behind me as if by seeing that sign meant that she could be going that speed. The cruise ship industry needs to fund crossing guards at every crosswalk if they're going to have thousands of people in town and allow locals to drive through downtown.	Kirby Day	Hi, this is Kirby Day from TBMP. Thank you for your message on the hotline today regarding pedestrian traffic and crossing guards. The crossing guard program is 100% funded by the cruise industry through the head tax/marine passenger fee. Over \$300,000 was allocated to the program this fiscal year, however Goldbelt Security has been unable to hire more than three (3) crossing guards so far. There are simply no applicants despite paying a significantly high hourly wage. We normally have 12 guards and to date we only have 3 who have taken the job. We continue to try to fill the ranks as we know how important the program is for locals and visitors alike. Thank you for reaching out.

It's much easier to see a vehicle, especially one that isnt familiar with the road, when youre on a bike, if they're driving with their headlights on. I've seen at least 10 jeeps on North Douglas since my initial call and none of them have had their lights on, so I dont know if you've contacted the operators or they're not complying with this request, but I'm asking again. Thank you.		We do our very best to ensure guests are aware of local road conditions for their safety and those they share the road with, however there isn't a local law that requires daytime running lights which makes it impossible to impose and segregates them from the hundreds of other Jeeps on the Juneau road system that do not use headlights during the day. Every driver is required to sign an agreement to abide by all local laws and we remind them to use their headlights on overcast days.

TEMSCO, Northstar, Coastal Helicopters, Kirby Day	Kirby Day: I explained to the caller that flight paths in and around the portion of the valley she is speaking of have not changed since 2019, when there were actually more flights than are currently being conducted in 2022. I also explained that routes into and out of the airport are controlled by the FAA Tower and operators need to follow those routes as established and agreed to and thus some routes into and out of the valley to and from the airport may also be affected by weather. I told the caller that I have shared her concern with operators and reiterated for all to use the established routes as dictated by weather and safety first.

Cant make work calls when Im working from home and there is so much use of the airwaves that my phone is not working. This has been going on for weeks now. So, that is a real problem that needs to be addressed.	Kirby Day, CLAA	Kirby Day: Thanks for using the TBMP hotline. I sent the following to Carnival Miracle regarding the outside announcements: Please note a comment on the Tourism Best Management Practices hotline along with a reminder of the guidelines all have signed onto for outside announcements, music, etc. (I sent them the TBMP guideline) basically there should be no outside announcements inbound after passing DuPont or outbound until DuPont. Regarding the phone issues, I think if you check with AT&T you'll find that the phone issues you may be having are not necessarily related to numbers of visitors in town, as the number is down 35% from a normal cruise season.

I just witnessed around the 14:25 hour, multiple large buses and semi- quasi transporter vans to the mini buses, parked on the side of Egan, on the wetlands side going southbound, looking at bears. Also, when the buses pulled back on to Egan, they almost caused a couple different accidents in the process. The other concern is over on the back loop by Brotherhood Bridge, I've seen several different various sizes of vehicles parked on the shoulder/sidewalk and its obstructing not just the pedestrians who want to walk but also the other cycling tours that utilize the shoulder to access their tour. Reading your email below, it is likely you have been hearing: A) Required 3 short blasts when ships go astern and back out of a dock or maneuver astern in the harbor. B) Required long blast (or more) if vessel is underway and another vessel is determined to be in the path and/or not responding to the arriving/departing vessel's maneuvers or radio C) Announcements made during required USCG drills, examinations or inspections as required by USCG. D) Whistles and/or bells signaling USCG drills, examinations or inspections as required by USCG E () long short blasts and 1 long blast on ship's whistle) As well, there have been instances when ships have forgotten that unless it is for an emergency or drills, inspections, exams, or safety purposes, outside announcements should not take place according to TBMP Guidelines (see guideline #52).
