So they cut off another vehicle trying to merge onto Egan so they could pass a box truck. I know everyones pretty tired this time of year but that was some pretty dangerous driving. Anyway, I hope you're all having a wonderful day and thanks for a great season.	Harv and Marvs	Driver accepts that it was driver error. Driver is normally a large diesel bus driver, and had never driven this small gas vehicle before. Even for personal use the driver uses a diesel vehicle. It was an anomaly that the driver was sent to make a small pick up at a hotel (No guests were on the vehicle). Driver did not realize how sensitive the accelerator was and while accelerating from the stop at McNuggett inadvertently pressed to hard on the accelerator and in so doing the sole of the large work boots he was wearing momentarily became lodged under the break pedal, thus holding the accelerator down. In an effort to avoid a collision, driver veered to the right as the left was completely blocked. The driver indicated that he feels the caller over exaggerated him cutting off a vehicle in the merge lane. He judged that this vehicle was 3 car lengths behind him, the driver will not operate this class of vehicle the remainder of the year.

Per the TBMP mission statement: "Begun in 1997, Tourism Best Management Practices (TBMP) are intended to minimize the impacts of tourism in a manner which addresses both residents and industry concerns." Holland America should have quarantined their guests (either on-board or in local hotels) rather than putting them on a ferry where they spread the virus and then on an airline for further transmission of the virus. Given that the cruises are only 2/3 full (so they say), why didn't they quarantine the covid patients in the empty rooms? It seems HA was only interested in protecting the cruise and didn't care about contaminating Alaska residents (on anyone else) with their Covid-ridden passengers. THIS HAS TO STOP IMMEDIATELY.	Kirby Day	Thank you for your email to TBMP. Apologies as for some reason we did not receive on 7th so it was forwarded to me today. Your concern and the response will be logged on the hotline database which is tallied each month. I wanted to clarify that these persons were never on the Holland America or any other cruise ship. They had completed their land tour in the interior and arrived in Skagway by motorcoach intending to board the ship for their cruise. As is policy, all those on the motorcoach go through mandatory COVID testing prior to boarding. This couple tested positive and thus were not allowed to board the ship. Consistent with the Port Agreements between the cruise lines and each port community, COVID positive passengers are not given the option to isolate in a hotel or go home. These passengers were provided with a hotel for isolation and chose (on their own) to leave early. (again, they were never onboard the ship and were refused boarding when they tested positive). Holland America's policy is as follows: Our policy for any guest that tests positive for COVID-19 is to advise them to isolate for at least five days before travel. We ensure they have the tools to do that, including assistance in arranging hotel accommodations throughout their stay. We cover up to \$100/day in meal deliveries and we reimburse the hotel expenses not covered by their trip insurance.

While fishing around 10am south of point retreat, the boat had plenty of room to spare but came by him within 50 feet, causing a 4 foot wake. It tipped over multiple items and there was an elderly male on board at risk of being injured. Caller has serious concerns with professionalism of boat driver.	49th Fathom Charters	Good morning! I have reached out to the caller via the phone number provided. I left a voicemail letting him know who I am and that I am the owner of the vessel and the charter company. I stated I was responding to a complaint received on the TBMP Hotline and wanted to find out more information regarding the specifics of the situation. The Alaskan C Gal was on a 4 hr. Salmon Fishing Charter and was trolling for salmon at Coordwood between the hours of 9am-11:15am on August 19th. I do not have any recollection of coming within a distance of 50 feet from any boat while at running speed. I will state that this is typically a heavily trafficked area especially Friday-Sundays during the month of August. We would have no reason to have been running full speed at 10am unless we were to have pulled lines to run back to troll in only one direction. Either way, it is not our practice or intention to wake anyone out, especially while trolling, as it happens all the time to us while trolling so I know what it's like. If this wake was indeed solely caused by my boat I do apologize for that and will remind all of my captains to be conscious and aware of the other boats around them while on the water so as to not cause large wakes while others are at slower speeds trolling.
8/21/2022 8/22/2022		Cruise: Noise Vehicle:		I am writing to report the Norwegian Spirit, 8/20/22 at approximately 8PM. I understand the importance of tourism to our community, but it is out of hand. The amount of pollution they create is untenable. I have attached a photo for you as well. Also, I do not know which ship was making announcements, but that has got to stop. We live here. Last night, I could hear the announcements at the docks clearly - and I live on Starr Hill. It is the responsibility of the cruisers to get on their ships on time, the announcements do not need to be blasted at F-35 decibel levels so the entirety of Downtown can hear them. This is not ok.
