Information obtained by our office indicates that your company operates commercial aircraft within the City and Borough of Juneau, Alaska (CBJ). Commercial aircraft operating within the CBJ is assessed based on the attached Aircraft Landing Formula which takes into consideration aircraft value, number of times landed annually and ground time factor (which is determined by gross takeoff weight). You are required by law to complete a filing form and return it to the Assessing Office each year.

In the space below, please list all commercial aircraft landed in the CBJ from January 1, 2016 through December 31, 2016. Your estimated value of each aircraft landed will assist us in valuing your property. A valid filing requires your signature and date. ## Aircraft Landing Formula

Members of the Anchorage Assessors Office and the Office of the State Assessor met with airline industry representatives in the late 1970's to work out what was thought to be an equitable plan on assessing scheduled aircraft carriers. It was agreed upon that the following formula would be used to assess scheduled aircraft, based up the number of landings each type made within the municipality.

Most municipalities still contact the Municipality of Anchorage to obtain estimated market values for the various aircraft types.

## Landing Formula

$$(\text{Market Value} \div \text{Ground Time Factor}) \text{ Total Landings per Annum} = \text{Assessed Value}$$

Ground Factor Time is figured based upon estimated aircraft turnaround time and Gross Takeoff Weight (GTW)		
Ground Time Factor	Gross Takeoff Weight in pounds	Estimated Ground Time
17,520	Less than 83,000	30 minutes
11,680	83,000 to 310,000	45 minutes
8,760	More than 310,000	60 minutes

## Example

ACME Airline Company has 200 landings of a 737-400 in the last year. For this purpose the aircraft is estimated to have market value of \$50,000,000.00. The company also has 100 landings of a 737-200 last year. These aircraft were estimated to have a market value of \$30,000,000.00. All of these aircraft weigh more than 310,000 lb.

$$50,000,000 \div 8,760 = 5707.76 \times 200 = 1,141,553$$

$$30,000,000 \div 8,760 = 3424.66 \times 100 = 342,466$$

$$\text{Total aircraft assessment} = \$1,484,018$$
