Bids will be accepted at the CBJ Purchasing Office only. Bids must be received at the CBJ Purchasing Office no later than 4:30 p.m., Alaska Time, Monday, August 18, 2014 in order to be considered. Late bids will not be accepted. A postmark by that date is insufficient.


