Dasher board & advertising contract will be for 365 days (per year of contract) beginning the first day of placement on Arena board system, first day of ice season for in-ice logos or day of payment for program sponsorship. Choice of rink board space is first come, first served. Board space will not be held for more than 10 business days without full payment. Failure to make payment will result in board space being offered to the next interested party. All advertising must meet the managers' approval before placement in the Arena. All advertising components and materials must conform to required specifications. Board shielding is furnished as-is. Advertisers wishing to replace existing shielding panels must do so at their own expense. Advertisers using painted or vinyl backed lexan are responsible for the materials and replacement costs of damaged signage. The Arena will only replace board shields when safety is an issue. Right of Renewal exists for 10 business days after the expiration of the contract period.
