A. JCOS Input to FY17-CBJ2022 Capital Improvement Program (CIP) List – Nancy Waterman discussed aspects of the CIP stating that comments needed to be sent to the planning commission by the 22<sup>nd</sup>. Beth McKibben explained the CIP and process involved. Duff Mitchell asked if Marine Passenger Funded projects were included in the CIP to which Ms. McKibben responded that they were. Mr. Mitchell motioned to facilitate the future of electric transportation which was seconded by John Smith. Mr. Mitchell also brought up the subject of electric bus acquisition and implementation for a potential comment subject. Mr. Mitchell motioned to have Steve Behnke and Amy Skilbred write a letter with generic language to address including references to the CAP in CIP project descriptions to be reviewed by Greg Smith before being sent to JCOS commissioners for further review. John Smith seconded the motion.
