INFORMATION RELEASE

Subject: Sexual Assault 2, Assault 3rd Degree, and Indecent Exposure 2nd Degree

Summary:

On March 25, 2010 at about 0315 hours, the Juneau Police Department received a report of a possible domestic disturbance in the 2000 block area of Great Western Avenue in Douglas. The complainant called to report a lot of yelling and banging around coming from a residence.

Officers arrived and met with a 27 year old female Juneau resident. The woman told officers that she confronted 28 year old Juneau resident Thomas SKEEK about how he acted toward a 36 year old female Juneau resident who was visiting. The woman confronted SKEEK because he forced himself sexually on the 36 year old. The 28 year old woman said after she confronted SKEEK he slapped, hit, strangled, and threatened to kill her while holding a knife, stabbing the knife into a wall near the woman several times. The woman said she lived in the residence with SKEEK and that SKEEK left prior to officer's arrival.

Officers also interviewed the 36 year old female Juneau resident who said she was at the residence to visit the 28 year old woman. She stayed at the residence while the other woman left for a short period of time. After the 28 year old left the home, SKEEK attempted several times to engage the woman sexually. The woman declined his advances and SKEEK fondled her with his hands several times through her clothing. The woman repeatedly told him to stop. SKEEK then exposed his genitalia to her and again touched her. The woman was able get away from SKEEK and leave the home.

Any charges reported in this press release are merely accusations and the defendants are presumed innocent unless and until proven guilty.
