On Thursday, July 8, 2010, at about 11:47 AM, the Juneau Police Department received a tip that Rorie Miller might be staying at an apartment in the 1600 block of Renninger Dr. When officers arrived at the location, they discovered Miller had left the apartment prior to their arrival. Officers learned Miller was possibly hiding in the wooded area near the apartments after he saw patrol cars in the area.

While officers were at the apartment, Miller returned. He spotted officers and fled, ignoring repeated commands from the officers that he was under arrest for his warrant. Following a short foot pursuit of about 200 yards, Miller was shot with a Taser and taken into custody. He was transported to Bartlett Regional Hospital for removal of the Taser barbs and because he appeared to be choking on a foreign substance.

At BRH, medical personnel removed a large plastic container that had lodged in Miller's throat. The container appeared to be filled with narcotics. Miller is currently being kept at BRH for examination. Following examination, Miller is expected to be taken to the Lemon Creek Correctional Center where he will be lodged without bail.

While police were investigating this case, they also contacted and arrested 25 year old Juneau resident Alicia Carson. She was charged with Violating Conditions of Release. She was taken to Lemon Creek Correction Center where she was lodged with \$1,000 bail.

Investigation into this matter continues and additional charges are pending.
