ACQUISITION: Transferred from the Alaska State Archives. Collection of documents related to the operation of the US District Marshal stationed in Juneau. Largely from 1902-1907 but some documents as from outside that range, as early as 1893. Documents relate to the operation of the judicial system, throughout Southeast Alaska. Records include: Accounts for Support of Prisoners, Accounts for Reimbursement of Jurors and Witnesses for service, Capias, Venire, Requests for business licenses (canneries, salteries, barrooms, merchantile, hotels), a small amount of material on general litigation, vouchers for payment of jurors and witnesses, subpoenas.

#### ACCESS:

This collection is available for viewing by appointment. However, the photographs may not be photocopied. The finding aid for the US District Marshal collection contains all the photographs received. Assistance may be required when using this collection.

COPYRIGHT:

Request for permission to publish or reprouce material from the collection should be discussed with the Curator of Collections.

**PROCESSING:** Most of the photographs were in good condition. The photographs are sleeved in archival polypropylene pages and housed in acid-free containers.

### **BIOGRAPHICAL/HISTORICAL NOTE:**

In February 1881, the U.S. Coast Guard arrived on the U.S.S. Jamestown under Commander Henry Glass and Lieutenant-Commander Charles Rockwell to establish "law and order" in Juneau. The Navy appointed highly placed Native males as policemen to help resolve disputes. Kawa.ée, from the Áak'w village, was one of those appointed policemen.

In 1900, Juneau became the seat of government for Alaska, and the citizens voted to become an incorporated city. Newly-elected officials began organizing and passing ordinances. Ordinance #2 in June 1900 provided for fire protection, with the City taking over the volunteer fire department, and Ordinance #5 in October 1900 created the Juneau Police Department. W.S. Staley was elected City Marshal, and Dan Kennedy was elected the night watchman.

Since then, the Juneau Police Department has been the main law enforcement agency for the City and Borough of Juneau. They provide 24-hour services and "strive to follow a community policing approach to address crime and the fear of crime in [the] community."
