INFORMATIONAL ITEMS:

- > Turf manufacturers may submit product specifications in advance of the Deadline for Bids to obtain pre-approval. Email information to jennifer mannix@ci.juneau.ak.us. A list of preapproved manufacturers/products will be posted on the website listed above and will be updated as approvals occur.
- > Photos of the existing field and recent repairs that have been made are posted at the website listed above.
- > The advertised construction estimate did not include the Additive Alternate work. The estimate for the Additive Alternate is \$80,000.

SPECIAL PROVISIONS:

Item No. 1: Section 00800 - Supplementary General Conditions

- > Article 13.6, One Year Correction Period, Paragraph E, Definitions, Number 3. Delete the following sentence:
 - "The term "Serviceable" in the context of this warranty, shall mean that the synthetic turf system shall have an average dynamic cushioning G value according to ASTM F355A no greater than 125 G's."

And *replace* with the following sentence:

"The term "Serviceable" in the context of this warranty, shall mean that the synthetic turf system shall have an average dynamic cushioning G value according to ASTM F355A no greater than 125 G's upon installation and shall not exceed 175 G's maximum during the warranty of the product."

Item No. 2: Section 01025 - Measurement and Payment, Article 2.3, Remove and Dispose of Existing Turf System, Paragraph B. *Add* the following:

"The WORK will also include removal and disposal of the existing geotextile fabric underpad that is located on the bottom of the existing turf surfacing material".

Item No. 3: Section 02240 - Synthetic Turf Surfacing

- Article 1.2, Minimum Synthetic Turf Contractor's Qualifications. *Delete* subparagraph 1 and *replace* with the following:
 - "1. Have installed a minimum of six (6) successful full-size outdoor football or soccer synthetic turf fields (minimum 70,000 sq. ft.) in the United States within the past three (3) years of tufted polyethylene grass-like fabrics that are filled with either all rubber or a mixture of SBR rubber and sand. "
- > Article 2.3, Requirements of Turf Surfacing System, Paragraph F. *Delete* paragraph and *replace* with the following:
 - "Fiber Type and Density: The turf surface shall use slit film polyethylene low-friction fibers with a minimum fiber density of 40 ounces per square yard."
- Article 3.2, Removal of Existing Turf System, Paragraph A, delete the first sentence and replace with the following:

"The existing turf surfacing material, rubber infill, and geotextile fabric under-pad that is located on the bottom of the existing turf surfacing material shall be removed in an orderly manner to avoid excessive disturbance to the underlying turf base material."
