## **PROJECT MANUAL:**

Item No. 1

SECTION 00030 - NOTICE INVITING BIDS. DEADLINE FOR BIDS.

Change the date of the Deadline for Bids from August 8, 2013 to August 13, 2013. The time remains the same.

Item No. 2

SECTION 03301 – STRUCTURAL CONCRETE, PART 2 - PRODUCTS:

Delete paragraph 2.14 FORMS in its entirety.

Item No. 3

SECTION 13130 - TENSION MEMBRANE STRUCTURE:

PART 1 - GENERAL

- 1.1 SUMMARY Paragraph A: Delete "designed for seasonal removal of the fabric."
- 1.2 PERFORMANCE REQUIREMENTS, Paragraph B. Structural Performance: following at the end of the sentence: "and the 2009 IBC including applicable local (CBJ) amendments. See Title 19 at Juneau.org under Community Development Department Codes Laws and Regulations http://www.juneau.org/cddftp/ordinances.php"
- 1.2 PERFORMANCE REQUIREMENTS, Paragraph B: Add Subparagraph, Number 3. Snow Load: Ground snow load 70 psf, roof snow load 50 psf.

PART 2 - PRODUCTS:

2.1 MATERIALS, Paragraph F. Construction: Add the following at the end of the sentence "as required to meet design loads."

Delete Paragraphs G, H, & I in their entirety.

- 2.3 PREFABRICATED STEEL TENSION MEMBRANE STRUCTURES, Paragraph A. Basis-of Design Product: *Change* first sentence to read "Basis of Design Product: Subject to compliance with requirements, provide Eide Industries (562-402-8335) or Fabritec Structures (714-427-6980) or an approved equal."
- FINISHES, Paragraph A. Galvanized-Steel Factory Finish: *Change* to read "Factory Finish: Immediately after cleaning and pretreating, apply manufacturer's standard two-coat, baked-on finish consisting of prime coat and thermosetting topcoat."

### **PLANS:**

Item No. 4 DRAWING SHEET 2.01, PARTIAL SITE PLAN:

Add the following SHEET note: "6. Provide planter walls around complete perimeter of the two landscape beds adjacent to People's Wharf. Planter wall shall be installed behind curbs in accordance with Detail 2/L4.06."

Item No. 5 DRAWING SHEET A3.01, SHUTTLE PARKING CANOPY ENLARGED PLAN AND SECTION, Detail 2 SHUTTLE PARKING CANOPY SECTION:

Add the following note "The curve of the arch is designed to match existing canopies on site. Modified curves may be proposed for approval provided the front height (left side of detail 2) remains 12'-6" clear and the back height (right side of detail 2) is not less than 9'-6". Proposed modified configurations will be subject to approval by the architect. If approval of modified configuration is not received, contractor is required to provide canopy configuration shown in contract documents."

Item No. 6 DRAWING SHEET A3.03, BUS CANOPY ENLARGED PLAN AND SECTION, Detail 2 BUS CANOPY SECTION:

Add the following existing canopy dimensional information: a) overall width of canopy from left edge to right edge is 12'-0". b) vertical height of arch is 2'-0". c) height from top of connector plate to bottom edge of arch is 2'-6" d) canopy at top of leading edge of arch is 12'-0" above the side walk. e) height from sidewalk to bottom of plate of existing 12" extender is 6'-6".

Item No. 7 DRAWING SHEET L4.03, PLANTING PLAN – Planting Schedule - Shrubs:

*Change* the size of the shrubs to the following:

Fagus sylvatica: Size #1

Rhododendron "Ramapo": Size #3 Spiraea bumalda"Shirobana": Size #3
