BACKGROUND:

Addendum Seven placed the bid opening for the Port of Juneau Cruise Berths project on hold due to an issue related to a pending state land conveyance. While final determination was not expected to occur until mid to end of January 2014, it now appears the issue will be resolved sooner. In consideration of this new development Bidders were contacted and it appears the preferred scenario is to move forward with determination of qualified Bidders and lowest bid selection based on the bidder qualifications and bids received on November 12, 2013. In order to allow this to occur we need all Bidders to acknowledge in writing an agreement to the terms of the bidding process. Attached to Addendum Eight is a Bid Process Certification that must be signed by a Bidder representative with authority to do so. All four Bidders who submitted bidder qualifications and bids must sign and submit the attached certification.

BIDDING PROCESS CERTIFICATION

WHEREAS, CBJ Docks and Harbors desires to construct the Port of Juneau Cruise Ship Berths project in a timely manner; and

WHEREAS, CBJ Docks and Harbors received contractor qualification statements and sealed bids on November 12, 2013; and

WHEREAS. The sealed bids received have been unopened and secured in a locked cabinet; and

WHEREAS, The bid opening has been on hold to resolve an issue relating to a pending state land conveyance: and

WHEREAS, Addendum Seven allowed Bidders to update bidder qualifications and bids: and

WHEREAS, Bidders who submitted bids on November 12, 2013 have verbally indicated a preference to open the original bids submitted.

NOW THEREFORE, The undersigned acknowledges and agrees to the terms of the bid process for the Port of Juneau Cruise Ship Berths project as stated below:

SECTION 1. Bidders agree that the bidder qualifications and sealed bids submitted on November 12, 2013 shall be the basis of selection of the lowest qualified bidder.

SECTION 2. CBJ Docks and Harbors will review Bidder Qualifications and post a listing of qualified bidders no later than December 27, 2013.

SECTON 3. Bidders retain bidder qualifications and bid protest rights as provided in Section 00100 – Instruction to Bidders, Title 20.0 – Filing a Protest. However, Bidders agree not to protest on the point of allowing updated qualification and bids as indicated in Addendum Seven.

SECTION 4. Bidders understand and agree that the bid price shall be held for 45 days from the day of bid opening in accordance with Section 00030 Notice Inviting Bids – Bid to Remain Open and Addendum Two Item 2.

SECTION 4. Bids of qualified bidders, as submitted on November 12, 2013, will be publically opened and read at 2:00 p.m. Alaska Time on January 8, 2014 in the Assembly Chambers, or such later date or time as announced by Addendum.

SECTION 5. Bidder has examined bid Addenda Seven and Eight.
