PROJECT MANUAL:

- Item No. 1 SECTION 01025 MEASUREMENT AND PAYMENT, PART 2 PAY ITEMS, DIVISION 1 GENERAL REQUIREMENTS, Article 2.15, SURCHARGE PERIMETER ROCKS, *Replace* Paragraph C with the following:
 - C. Boulders existing on site used as Surcharge Perimeter Rocks shall be included in measurements for payment for Surcharge Perimeter Rocks.
- Item No. 2 SECTION 02301 WICK DRAINS, PART 3 EXECUTION, Article 3.1 CONSTRUCTION, *Replace* Paragraph K with the following:
 - K. The CONTRACTOR shall install the wick drains prior to the instrumentation devices. The CONTRACTOR shall take all necessary precautions to protect instrumentation and other surveying devices while conducting the WORK. The CONTRACTOR shall replace, at no cost to the OWNER, instrumentation that is damaged or becomes unreliable as a result of the CONTRACTOR's operations.
- Item No. 3 SECTION 02402 SANITARY SEWER MANHOLES AND CLEANOUTS, PART 2 PRODUCTS, Article 2.1 MANHOLES, **Delete** Paragraph B in its entirety.
- Item No. 4 SECTION 02502 STORM SEWER MANHOLES, INLETS AND CATCH BASINS, Article 2.5 PRECAST CONCRETE UNITS, **Delete** Paragraph C in its entirety.
- Item No. 5 SECTION 02707 FENCING, PART 2 PRODUCTS, Article 2.2 TIMBER FENCE, Paragraph D, PRESERVATIVE TREATMENT, Item 1, **Add** the following sentence:

All timber materials shall be pressure treated to the standards of AWPA U1, use Category UC4A.

Item No. 6 SECTION 11100 – INSTRUMENTATION, *Add* the following Article to the end of PART 3 – EXECUTION:

3.5 PROTECTION AND MAINTENANCE OF INSTRUMENTATION

- A. In addition to other protection and maintenance requirements as specified herein, the CONTRACTOR shall take all necessary precautions to protect instrumentation and other surveying devices while conducting the WORK. The CONTRACTOR shall maintain, in serviceable condition, all instrumentation for the duration required to complete the WORK. The CONTRACTOR shall replace, at no cost to the OWNER, instrumentation that is damaged or becomes unreliable as a result of the CONTRACTOR's operations.
- Item No. 7 SECTION 13121 COVERED SHELTER, PART 2 MATERIALS, Article 2.1 MATERIALS, *Add* the following sentence to the end of Paragraph A:

 All sawn lumber shall be pressure treated per AWPA C2 for use Category UC3B per AWPA U1.

PLANS:

- Item No. 8 DRAWING SHEET L3.01, PLANTING PLAN, Planting Legend, Deciduous Trees, Replace the entire table row referencing AA, Amelanchier arborea, with T-M Transplant Maple.
- Item No. 9 DRAWING SHEET L3.02, PLANTING PLAN, **Delete** the entire table row referencing AA, Amelanchier arborea, from the Planting Legend, Deciduous Trees.

Delete the entire table row referencing GP, Geranium Patricia, from the Planting Legend, Perennials.

From the Planting Legend, Perennials **Replace** HM: Heuchera micrantha 'Palace Purple' with IS: Iris Setosa.
