The following items of the contract are modified as herein indicated. All other items remain the same. This addendum has been issued and is posted online. Please refer to the CBJ Engineering Contracts Division webpage at: http://www.juneau.org/engineering_ftp/contracts/Contracts.php

CLARIFICATIONS:

- A city plan and code review is not applicable to this contract. A permit application and plan review will be applied and fee paid by the Owner in March 2016 as part of the upcoming Capital Transit Facility Renovation project.
- Trench drain metal grates will be furnished and installed by the Owner's separate Contractor.
- Water softener equipment is NOT required. Juneau's water is 'Soft' at an average reading of 60 mg/L as (CaCO3) in 2015.

PROJECT MANUAL:

Item No. 1: SECTION 00300 – BID, Paragraph 9. TO BE CONSIDERED, ALL BIDDERS MUST COMPLETE AND INCLUDE THE FOLLOWING AT THE TIME OF THE DEADLINE FOR BIDS: **Add** the following bullet item:

- "Per Alaska Statute AS 08.18, bidders will be required to provide an Alaska Contractors License and an Alaska Business License with their bid documents."
- Item No. 2: SECTION 11150 VEHICLE WASHING EQUIPMENT, PART 1 GENERAL, Article 8 TRAINING, Paragraph A. *Add* the following sentence:

"Provide a minimum of 8 hours of training."

Item No. 3: SECTION 11150 – VEHICLE WASHING EQUIPMENT, PART 1 – GENERAL, Article 9 – QUALITY ASSURANCE, Paragraph B. *Delete* in its entirety.

- Item No. 4: SECTION 11150 VEHICLE WASHING EQUIPMENT, PART 1 GENERAL, Article 10 DELIVERY, STORAGE, AND HANDLING, Paragraph A, Subparagraph 1. **Delete** the word "General" and **replace** with the words "Owners Separate."
- Item No. 5: SECTION 11150 VEHICLE WASHING EQUIPMENT, PART 1 GENERAL, Article 10 DELIVERY, STORAGE, AND HANDLING, Paragraph B: **Delete** the first sentence of this paragraph and **replace** with the following:

"Ship all products and store them onsite in weather tight, enclosed containers until permanent installation."

Item No. 6: SECTION 11150 – VEHICLE WASHING EQUIPMENT, PART 1 – GENERAL, Article 12 – SCOPE OF RESPONSIBILITY, Paragraph A, Subparagraph 1. *Add* the following to the first sentence of this paragraph:

"... and motor starters and compressors."

Paragraph B, Subparagraph 1. *Delete* this paragraph and *replace* with the following:

"1. All field electrical work, including conduit and wiring runs and interconnections between all wash system components and power to the wash control panel and other work required by Alaska statute to be accomplished by a licensed electrical contractor shall be accomplished by the Owners Separate Contractor."

Paragraph C, Subparagraph 1. **Delete** this paragraph and **replace** with the following:

"1. All field plumbing and mechanical work including plumbing supplies and hand valves required between all wash system components, compressed air connections and other work required under Alaska statute to be accomplished by a licensed mechanical contractor shall be accomplished by the Owners Separate Contractor."

Paragraph D. **Delete** the term "General Contractor" and **replace** with "Owners Separate Contractor".

Paragraph E. *Delete* this paragraph and *replace* with the following:

"Accessories: Bus wash manufacturer is to provide and install all concrete mounted rails, guides, inserts etc. required for the operation of the wash equipment."

- Item No. 7: SECTION 11 VEHICLE WASHING EQUIPMENT, PART 2 PRODUCTS, Article 3 UTILITY REQUIREMENTS, Paragraph A, Subparagraph 2. **Delete** this paragraph in its entirety. Compressors must be provided by Bus Wash Manufacturer.
- Item No. 8: SECTION 11 VEHICLE WASHING EQUIPMENT, PART 3 EXECUTION, Article 3 Paragraph B, Subparagraph 1. Add the following subparagraph g.:
 - "g. Provide commissioning of the bus wash equipment, operating and adjusting the work so that it operates under the strict performance of the published system specifications."

Subparagraph 2. Delete sentence "d" and replace it with the following:

"d. Install duplex outlets required for operation of the work."

Add the following Subparagraph 3:

"3. Additional Work by Others:

Bus wash manufacturer shall be responsible for supplying all bus wash equipment and installing all such equipment, except work that is required under Alaska statute to be accomplished by a licensed mechanical or electrical contractor. Work required to be accomplished by licensed mechanical or electrical contractors shall be accomplished by the Owners separate contractor in a separate phase and is not a part of this bid."
