- Item No. 2 SECTION 005200 AGREEMENT, *Delete* in its entirety and *replace* with the attached AGREEMENT 00 5200, labeled Addendum No. 1.
- Item No. 3 SUPPLEMENTARY GENERAL CONDITIONS OF THE CONTRACT 008000, SGC 2: INSURANCE AMOUNTS, Paragraph D. Builders Risk insurance. *Delete* in its entirety and *replace* with:
  - "D. Builders Risk insurance is not required for this project."
- Item No. 4 SECTION POLYVINYL-CHLORIDE (PVC) ROOFING 075419, PART 1 GENERAL, Article 1.11 WARRANTY *Delete* in its entirety and **replace** with the following:

#### "1.11 WARRANTY

- A. Special Warranty: Manufacturer's standard or customized form, without monetary limitation, in which manufacturer agrees to repair or replace components of membrane roofing system that fail in materials or workmanship within specified warranty period.
  - 1. Special warranty includes membrane roofing, base flashings, roof insulation, fasteners including non-penetrating fasteners, cover boards, substrate board, vapor barrier, insulation

- adhesive, roofing accessories, walk pads and other components of complete membrane roofing system.
- a. Failure means leaks, damage to building not accessible to water intrusion, delamination of roofing assembly components, adhesive failure, seismic joint failure, failure of non-penetrating fasteners or any other conditions that would render reassembly ineligible for membrane manufactures warranty.
- 2. Insulation Thermal Warranty: Provide a 20 year thermal warranty for the insulation.
- 3. Warranty Period: 20 years from date of Substantial Completion of General Contract.
  - Only Special Warranty provided directly by Manufacturer will be accepted. Special Warranty by third party will not be considered.
- 4. Litigation In the event that litigation should be required, it shall occur in a court in the State of Alaska
- 5. Warranty to include coverage for 110 mph 3 second peak gust.
- B. Special Project Warranty: Submit roofing Installer's warranty on warranty form at end of this Section, signed by Installer, covering the Work of this Section, including all components of membrane roofing system such as membrane roofing, base flashing, roof insulation, fasteners, cover boards, substrate boards, vapor retarders, and walkway products, for the following warranty period:
  - 1. Warranty Period: Two years from date of Substantial Completion of General Contract."
- Item No. 5 SECTION POLYVINYL-CHLORIDE (PVC) ROOFING 075419, PART 2 PRODUCTS, Article 2.3 PVC ROOFING. *Delete* in its entirety and **replace** with the following:

#### "2.3 PVC ROOFING

- A. PVC Sheet: ASTM D 4434/D 4434M, Type III, fabric reinforced.
  - Manufacturers: Subject to compliance with requirements, available manufacturers offering products that may be incorporated into the Work are limited to the following:
    - a. <u>Carlisle SynTec Incorporated</u>. Basis of Design: Sure-Flex Membrane.
    - b. <u>Sika Sarnafil AG</u>
    - c. Johns Manville; a Berkshire Hathaway company.
  - 2. Thickness: 80 mils. nominal.
  - 3. Exposed Face Color: Gray."
- Item No. 6 SECTION POLYVINYL-CHLORIDE (PVC) ROOFING 075419, PART 2 PRODUCTS, 2.4 AUXILIARY ROOFING MATERIALS. *Add* Paragraph H.
  - "H. Contractors option in lieu of fully adhered roofing system a Non-Penetrating Mechanically Fastened Roofing System is acceptable. Provide proprietary clad metal plate/fastener system for use with electromagnetic induction welding technology.

Item No. 7 SECTION WIRE MESH STORAGE LOCKERS – 105143, PART 2 – PRODUCTS, Article 2.1 – TURNOUT GEAR LOCKERS, Paragraph B. *Change* Locker size *from* (25 1/4"wide, 79" high x 20" deep) *to* (24" wide x 74 1/2" high x 20" deep).

- Item No. 11 Sheet A501 INTERIOR ELEVATIONS, Detail 1 SCBA 140 WEST. *Replace* "File Cab" with "3 drawers of equal height".

This Bid is genuine and not made in the interest of or on behalf of any undisclosed person, firm or corporation and is not submitted in conformity with any agreement or rules of any group, association, organization or corporation; Bidder has not directly or indirectly induced or solicited any other Bidder to submit a false or sham Bid; Bidder has not solicited or induced any person, firm or corporation to refrain from bidding; and Bidder has not sought by collusion to obtain for itself any advantage over any other Bidder or over Owner.

THIS AGREEMENT is between THE CITY AND BOROUGH OF JU	UNEAU (hereinafter called Owner) and

and Contractor, in consideration of the mutual covenants hereinafter	set forth, agree as follows:

#### ARTICLE 1. WORK.

Contractor shall complete the Work as specified or as indicated under the Bid Schedule of the Owner's Contract Documents Contract E16-146/AIP No. 3-02-0133-xxx-2016, named JNU Aircraft Rescue & Firefighting Station Modifications.

The Work is generally described as follows: Replacing existing Aircraft Rescue & Fire Fighting (ARFF) apparatus bays with larger facility. Work will include demolishing portions of existing building, and rebuilding in same general location, and miscellaneous related Work.

The Work to be paid under this contract shall include the following: Total Bid as shown in Section 004114 - Bid Schedule.

#### ARTICLE 2. CONTRACT COMPLETION TIME.

The Work must have substantial completion by June 1, 2017. Final completion shall be by July 1, 2017.

#### ARTICLE 3. DATE OF AGREEMENT

The date of this agreement will be the date of the last signature on page three of this section.

#### ARTICLE 4. LIQUIDATED DAMAGES.

Owner and the Contractor recognize that time is of the essence of this Agreement and that the Owner will suffer financial loss if the Work is not completed within the time specified in Article 2 herein, plus any extensions thereof allowed in accordance with Article 8 of the General Conditions. They also recognize the delays, expense, and difficulties involved in proving in a legal proceeding the actual damages suffered by the Owner if the Work is not completed on time. Accordingly, instead of requiring any such proof, the Owner and the Contractor agree that as liquidated damages for delay (but not as a penalty) the Contractor shall pay the Owner \$1,000 for each Day that expires after the completion time(s) specified in Article 2 herein. The amount of liquidated damages specified above is agreed to be a reasonable estimate based on all facts known as of the date of this Agreement.

#### ARTICLE 5. CONTRACT PRICE.

Owner shall pay Contractor for completion of the Work in accordance with the Contract Documents in current funds the amount set forth in the Bid Schedule. The Contractor agrees to accept as full and complete payment for all Work to be done in this contract for: <u>CBJ Contract E16-146/AIP No. 3-02-0133-xxx-2016</u>, named <u>JNU Aircraft Rescue & Firefighting Station Modifications</u>, those Lump Sum amounts as set forth in the Bid Schedule in the Contract Documents for this Project.

#### ARTICLE 6. PAYMENT PROCEDURES.

Contractor shall submit Applications for Payment in accordance with Article 14 of the General Conditions. Applications for Payment will be processed by the Architect as provided in the General Conditions.

Progress payments will be paid in full in accordance with Article 9 of the General Conditions until ninety (90) percent of the Contract Price has been paid. The remaining ten (10) percent of the Contract Price may be retained, in accordance with applicable Alaska State Statutes, until final inspection, completion, and acceptance of the Project by the Owner.

No assignment by a party hereto of any rights under or interests in the Contract Documents will be binding on another party hereto without the written consent of the party sought to be bound; and specifically but without limitation monies that may become due and monies that are due may not be assigned without such consent (except to the extent that the effect of this restriction may be limited by law), and unless specifically stated to the contrary in any written consent to an assignment, no assignment will release or discharge the assignor from any duty or responsibility under the Contract Documents.

Owner and Contractor each binds itself, its partners, successors, assigns and legal representatives to the other party hereto, its partners, successors, assigns and legal representatives in respect of all covenants, agreements and obligations contained in the Contract Documents. This Agreement shall be governed by the laws of the State of Alaska. Jurisdiction shall be in the State of Alaska, First Judicial District.
