- Item No. 3: SECTION 02870 SITE FURNISHINGS, PART 2 PRODUCTS, Article 2.1 MANUFACTURERS AND PRODUCTS, Paragraph A Products, Item 5 Picnic Tables: Type A 4 bench. **Delete** in its entirety and **replace** with the following:
 - "5. Not Used."
- Item No. 4: SECTION 02870 SITE FURNISHINGS, PART 2 PRODUCTS, Article 2.1 MANUFACTURERS AND PRODUCTS, Paragraph A Products, Item 12 Custom Commemorative Bridge Bench. *Add* the following sentence to the first paragraph:

"Manufacturer shall be experienced in fabrication of similar precast park features, equal to Quick Crete Products Corp, 866-703-3434."

Aluminum Whale Tail Bench by Blastworks Art & Sign, or approved equal. 6' wide x 6' long x 20" seat height. Installation Method: Underground Hidden Mount / Slab Not Visible as per manufacturer's specifications and modified with brick paver installation over hidden slab.

Provide a clear coated Level 2 (sanded to 120gr) Finish.

- Item No. 9: SECTION 03450 PRECAST ARCHITECTURAL CONCRETE, PART 1 GENERAL, Article, 1.6. QUALITY ASSURANCE, Paragraph A. **Delete** in its entirety and **replace** with the following:
 - "A. Fabricator Qualifications: Precast concrete plant with at least 15 years of experience manufacturing items similar in nature to the work required under this contract."
- Item No. 10: SECTION 03450 PRECAST ARCHITECTURAL CONCRETE, PART 2 PRODUCTS, Article 2.1 PERFORMANCE REQUIREMENTS, Paragraph A. *Delete* and *replace* with the following:
 - "A. Not used."

- Item No. 13: SHEET L-151 – LANDSCAPE MATERIALS DETAILS. *Change* the title of Detail F – LANDSCAPE STEPPING STONE to Detail D - LANDSCAPE AND INTERTIDAL STEPPING STONES.
- Item No. 14: SHEET E-102 SITE POWER & LIGHTING PLAN BRIDGE PARK. Add the following NOTE 4:
 - "4. The utility work identified to be provided by AEL&P, including the utility pole relocation, medium voltage underground feeder to the padmount transformer, the padmount transformer, and the secondary feeder to the service switchboard will be paid by CBJ to AEL&P. AEL&P may include, at their own expense, the provision of a padmount switch and medium voltage feeders beneath the Douglas Bridge and to West Eighth Street as part of their system upgrades. Provide work coordination."
