A maximum of 2 work trucks may be inside the property boundary; all additional vehicles will need to be parked outside the fenced areas. CBJ will provide a 15' x 35' conditioned workspace for storage of piping materials and screens for a maximum of 7 days before installation of each. Storage may be used during the 10 day shutdown. Storage must be arranged with the Utilities Superintendent a minimum of 7 days in advance of storage space being required. Temporary power is available but connection and power costs will be the Contractors responsibility per Section 015000."

Item No. 5: SECTION 011413 – SITE ACCESS AND STORAGE, PART 1 – GENERAL, Article 1.4 WORK RESTRICTIONS. *Add* paragraph G.

- "G. No anchoring system may be installed at either facility that requires anchors or bolts to penetrate the facility walls without prior approval from the CBJ Utility Manager. Any anchoring system requests must include documentation that shows that the anchoring system will not cause harm to the existing walls, and must be structurally designed to support expected loads."

 - "L. The trolley system and hoist has a maximum load of 2 tons. The Contractor shall not overload either the trolley system or hoist. For the Contractor to use the crane/hoist system at the Mendenhall plant the following conditions must be met:
 - 1. Contractor shall have an OSHA certified hoist/crane operator, an OSHA certified rigger (class II or higher), and a trained signals person. Certificates must be supplied to CBJ before work begins and operating personnel must match the certification credentials."

PRE-BID CONFERENCE. The object of the conference is to acquaint Bidders with the project and bid documents. There will be a walk-through of both facilities following the meeting.

DESCRIPTION OF WORK. The WORK is generally described as follows:

Mendenhall Valley Wastewater Treatment Plant (MWWTP): The improvements to the headworks includes removal of one existing automatic screen and grinder system and one manual bar screen, the installation of two new perforated plate screens and screening washer/compactors including new electrical connections to the screens and compactors, dismantling and removing an oil/water separation tank, relocating an existing grit classifier clarifier and conveyor, and modifications to the piping in the influent pump station, painting of pipe, installation of gas alarms, and miscellaneous related WORK. Installation of the new screens will require construction sequencing to dismantle and replace existing 16-inch and 18-inch ductile iron pipe and new 24-inch process piping to make space for the new screens.

Juneau-Douglas Wastewater Treatment Plant (JDTP): The improvements to the headworks includes the installation of two new perforated plate automatic screens and screening washer/compactors including new electrical connections to the screens and compactors, construction of new concrete influent channels and piping to connect the new influent channels to existing piping, construction of a new building around the new channels and miscellaneous related WORK. Site grading includes the installation of two new catch basins, new storm drain lines, and asphalt restoration. Demolition includes the removal of the existing automatic screen and manual screen, removal of existing concrete steps, removal of a timber framed wall and soffit, and removal of electrical feeds to the existing screens. THIS AGREEMENT is between <u>THE CITY AND BOROUGH OF JUNEAU</u> (hereinafter called OWNER) and _______ (hereinafter called CONTRACTOR) OWNER and CONTRACTOR, in consideration of the mutual covenants hereinafter set forth, agree as follows:

ARTICLE 1. WORK.

CONTRACTOR shall complete the WORK as specified or as indicated under the Bid Schedule of the OWNER's Bid Documents entitled <u>Contract No. BE17-033, CBJ Headworks Improvements</u>.

The WORK is generally described as follows:

Mendenhall Valley Wastewater Treatment Plant (MWWTP): The improvements to the headworks includes removal of one existing automatic screen and grinder system and one manual bar screen, the installation of two new perforated plate screens and screening washer/compactors including new electrical connections to the screens and compactors, dismantling and removing an oil/water separation tank, relocating an existing grit classifier clarifier and conveyor, and modifications to the piping in the influent pump station, painting of pipe, installation of gas alarms, and miscellaneous related WORK. ARTICLE 3. DATE OF AGREEMENT

The date of this Agreement will be the date of the last signature on page three of this section.

ARTICLE 4. LIQUIDATED DAMAGES.

OWNER and the CONTRACTOR recognize that time is of the essence of this Agreement and that the OWNER will suffer financial loss if the WORK is not completed within the time specified in Article 2 herein, plus any extensions thereof allowed in accordance with Article 12 of the General Conditions. They also recognize the delays, expense, and difficulties involved in proving in a legal proceeding the actual damages suffered by the OWNER if the WORK is not completed on time. Accordingly, instead of requiring any such proof, the OWNER and the CONTRACTOR agree that as liquidated damages for delay (but not as a penalty) the CONTRACTOR shall pay the OWNER for each Day that expires after the completion time specified in Article 2 herein. The amount of liquidated damages specified below is agreed to be a reasonable estimate based on all facts known as of the date of this Agreement.

ARTICLE 5. CONTRACT PRICE.

OWNER shall pay CONTRACTOR for completion of the WORK in accordance with the Contract Documents in the amount set forth in the Bid Schedule. The CONTRACTOR agrees to accept as full and complete payment for all WORK to be done in this contract for: <u>Contract No. BE17-033, CBJ Headworks</u> <u>Improvements</u>, those Lump Sum amounts as set forth in the Bid Schedule in the Contract Documents for this Project.

The total amount of this contract shall be ______(\$____), except as adjusted in accordance with the provisions of the Bid Documents.

ARTICLE 6. PAYMENT PROCEDURES.

CONTRACTOR shall submit Applications for Payment in accordance with Article 14 of the General Conditions. Applications for Payment will be processed by the ENGINEER as provided in the General Conditions.

Progress payments will be paid in full in accordance with Article 14 of the General Conditions until ninety (90) percent of the Contract Price has been paid. The remaining ten (10) percent of the Contract Price may be retained, in accordance with applicable Alaska State Statutes, until final inspection, completion, and acceptance of the Project by the OWNER.

No assignment by a party hereto of any rights under or interests in the Contract Documents will be binding on another party hereto without the written consent of the party sought to be bound; and specifically but without limitation monies that may become due and monies that are due may not be assigned without such consent (except to the extent that the effect of this restriction may be limited by law), and unless specifically stated to the contrary in any written consent to an assignment, no assignment will release or discharge the assignor from any duty or responsibility under the Contract Documents.

OWNER and CONTRACTOR each binds itself, its partners, successors, assigns and legal representatives to the other party hereto, its partners, successors, assigns and legal representatives in respect of all covenants, agreements and obligations contained in the Contract Documents. This Agreement shall be governed by the laws of the State of Alaska. Jurisdiction shall be in the State of Alaska, First Judicial District.




