Item No. 1 SECTION 00030 - NOTICE INVITING BIDS.

Change Substantial Completion date *from* Dec. 5, 2018 *to* January 14, 2019 *Change* Final Completion date *from* December 15, 2018 *to* February 1,2019

Item No. 2 SECTION 00500 – AGREEMENT – ARTICLE 2, CONTRACT COMPLETION TIME.,

Change WORK must be completed by date *from* December 15, 2018 *to* February 1, 2019

Item No. 3 SECTION 00800 - S.G.C. 5.2, Insurance Amounts, C. – Builders Risk,

Replace with the following:

"CONTRACTOR is not required to obtain a Builder's Risk insurance policy for this project. The OWNER carries Builder's Risk insurance. Once this contract is awarded, the OWNER will have the CONTRACTOR and all Subcontractors added as named insureds for this project. If a Builder's Risk claim is filed for this project, the CONTRACTOR will we responsible for the first \$10,000 of the policy's deductible, and the OWNER will be responsible for the remaining deductible."

- Note 7: *Add* the following "Reinstall wall mount shelving units. Provide 4"H PLAM apron panel mounted end to end, approximately 36"W, under horizontal shelf to support new light fixture, see ELECT"
- Item No. 5 DRAWING E001 LEGEND AND ABBREVIATIONS
 - 1. **Delete** Sheet Notes 1 and 2.
- Item No. 6 DRAWING E201 SECOND FLOOR POWER AND SIGNAL PLAN
 - 1. **Add** Sheet Note 7 as follows: "Provide single station smoke alarms in sleeping rooms. Provide system smoke detectors in non-sleeping rooms."
 - 2. **Revise** TEF-4 control to (2) single pole switches.
 - 3. *Revise* Sheet Note 4 as follows: "The toilet exhaust fans (TEF-1, 2, 3, and 4) have on-off control with a HI-LOW Module"

Item No. 7 DRAWING E301 – SECOND FLOOR LIGHTING PLAN

- 1. Provide an occupancy sensors in Laundry 208 and Janitor 215, in lieu of line voltage toggle switches. Dual technology wall switch Wattstopper Catalog No. DSW-301-I, or equal.
- 2. Add a type B light fixture in Bath 206. Refer to sketch SK-E301.
- 3. *Revise* Sheet Note 2 as follows: "Mount Type H light fixture to new apron on shelf above bed. Coordinate with the General Contractor."

 - 1. **Revise** Type H light fixture to be provided by the Contractor: Manufacturer Scott Lamp Company, Catalog Number 3834.
